# Aventus Holdings Limited – Admission and Commencement of Official Quotation of Stapled Securities in Aventus Group

#### **Description**

Aventus Retail Property Fund (the 'Fund') is currently admitted to the Official List of ASX Limited ('ASX') and trades under the ASX code AVN.

On 25 September 2018, unitholders of the Fund approved resolutions to internalise the management of the Fund, whereby each share in Aventus Holdings Limited (the 'Company') will be stapled to each unit in the Fund (the 'Internalisation Proposal').

After the implementation of the Internalisation Proposal, each existing unitholder of the Fund will hold a new stapled security each comprising of one fully paid ordinary unit in the Fund and one fully paid ordinary share in the Company ('Stapled Securities').

The Company is expected to be admitted to the Official List of ASX on Thursday, 27 September 2018 at which point the new stapled entity will trade as Aventus Group.

Official quotation of the Stapled Securities is expected to commence on a deferred settlement basis as part of Group 1 at 10:00:00 am (+/- 15 seconds) AEST on Thursday, 27 September 2018.
