- 8.1- The Company received several loans from Bank Mizrahi Tfahot in Israel. As of September 30, 2018, the total amount of these loans is: US\$ 1.804 M.

The loans are denominated in US Dollars and NIS and bear interest rates of Libor + (2.5%-3%) and prime+ (0.5%- 0.85%) per annum.

The Company's major shareholder provides a guarantee for part of these loans payments.

Upon CardioStaff acquisition, additional long- term loans were added to the Company balance. As of September 30, 2018, the total amount of these loans is US\$ 1.310 M and include mainly loans from private people/institutions and bear interest of 4%-12% per annum.

8.3- Loans from controlling shareholder (Yacov Geva)- In addition to the previous loan to the Company of approximately US\$0.5 M (bear interest of Libor +3%), Yacov Geva has entered into a loan agreement in May 2018, to provide the Company with a loan of up to US\$ 3M. During the current quarter, as part of an amendment to the loan agreement, the Company received additional funds and has the option to receive a loan in the aggregate amount of up to US\$ 10M, include the amounts already received from Yacov Geva.

As of September 30, 2018, the total amount of this loan that is available is US\$5,18 M.
