FOD receives China Inspection and Quarantine Certificate (CIQ) for Fruit Farm 2 Litre Orange Juice

Highlights:

- **China Inspection and Quarantine Certification (CIQ) approval received for FOD's Fruit Farm Orange Juice in only 10 days – leveraging the expertise of incoming Executive Chairman Norman Li**
- **CIQ approval means that FOD's products are now approved for sale in physical stores in China**
- **Company's focus is to achieve CIQ certification for all FOD products**
- **As previously announced, FOD has developed a cold fill technology to increase the shelf life of ambient juice allowing the Company to send long life juice utilising freight**
- **FOD working towards distribution deals in near term and will be participating in the China International Import Expo in Shanghai next week**

The Food Revolution Group Limited (ASX: FOD) is pleased to announce it has received notification that it has gained China Inspection and Quarantine Certification (CIQ) for its Fruit Farm Orange Juice products.

FOD shipped a pallet of Fruit Farm 2 Litre Orange Juice to Shanghai for the China International Import Expo where it will have a booth together with its distributor Careline. The products gained CIQ approval in only 10 days.

FOD previously announced that it has developed a cold fill technology to increase the shelf life of ambient juice allowing the Company to send long life juice utilising freight. Together with the CIQ certification and the Company's growing Chinese distribution capabilities, FOD is in a very strong position to launch products into the China market.

FOD's growth strategies are very focused on selling functional foods and food supplements into China. Having this initial product gain CIQ approval in an expedited timeframe is critical in achieving this vision. This is the first product that FOD and Careline have collaborated on to obtain CIQ approval with many more in the pipeline.

Norman Li, the incoming Executive Chairman of FOD said: "This is good news for FOD's strategic vision to quickly grow our presence in China. We received the Chinese CIQ very fast. I congratulate the team for their hard work in getting all the documentation together making it easier for us to obtain the certification.

“We will now show Fruit Farm 2 Litre Orange Juice at the China International Import Expo in Shanghai next week and hope to generate firm orders very soon. Through our distribution contacts, we are seeing that due to the current tariff threat there is a shift away from American juice products to alternative sources of supply such as Australia. The focus of our compliance team now shifts to getting CIQ approval for our existing and new products we are developing for the Chinese market.”
