New contract to supply a suite of MyHealth1st products to SmartClinics fast-growing GP medical centres group

Under the agreement, 1st Group will provide the SmartClinics network with the MyHealth1st Online Appointment solution, EasyFeedback, EasyRecalls and 1st Insights Business Intelligence reporting, all of which are integrated with the network's practice software systems.

1st Group will receive monthly recurring subscription fees, as well as usage and setup fees. Average revenue per site under the contract is over four times 1st Group's average revenue per site, reflecting the range of products being provided. This highlights the upsell opportunity with other customers across the group.
