#### Pre-quotation disclosure

The following information is required to be provided to ASX Limited (**ASX**) for release to the market in connection with the official quotation and deferred settlement trading of the fully paid ordinary shares in Coles Group Limited (**Coles**) which will commence at 11:00am (AEDT) on 21 November 2018.

Unless otherwise defined, capitalised terms in this document have the same meaning they have in the scheme booklet released to ASX by Wesfarmers Limited (**Wesfarmers**) on 5 October 2018 (**Scheme Booklet**).

#### 1 Indicative statement of the 20 largest shareholders

Attachment 1 is an indicative statement of the 20 largest shareholders of Coles.

The statement sets out an indicative list of the names of the 20 largest shareholders of Coles Shares, being the only class of securities of Coles to be quoted, and the number of Coles Shares held by those holders.

#### 3 Shareholder entitlement

To effect the Demerger of Coles from Wesfarmers:

- each Wesfarmers Shareholder (other than Ineligible Overseas Shareholders and Selling Shareholders) will receive one Coles Share for each Wesfarmers Share that they hold as at the Record Date (expected to be 4.00pm (Perth time) on Thursday 22 November 2018); and
- (b) for each Ineligible Overseas Shareholder and Selling Shareholder, the Sale Agent will receive one Coles Share for each Wesfarmers Share held by the Ineligible Overseas Shareholder and Selling Shareholder as at the Record Date.
