# Revasum, Inc. (ASX: RVS) – Admission and Commencement of Official Quotation – Deferred Settlement Trading

#### **Description**

Revasum, Inc. ('RVS') is expected to be admitted to the Official List of ASX Limited ('ASX') on Tuesday, 4 December 2018.

Official quotation of RVS's ordinary fully paid CDIs is expected to commence at 12:00pm AEDT on Tuesday, 4 December 2018 on a <u>deferred settlement basis</u>.

Each CDI represents fully paid ordinary shares in RVS at a ratio of 1 for 1.

RVS raised \$30.7 million pursuant to the offer under its prospectus dated 9 November 2018 ('Prospectus') by the issue of 15,357,143 CDIs at an issue price of \$2.00 per CDI.
