Director Resignation

Stanmore Coal Limited (Stanmore or the Company) (ASX: SMR) today announced the resignation of Mr Chris McAuliffe as a Director.

Mr McAuliffe was a nominee director of Greatgroup Investments Pty Limited ("Greatgroup"). On 19 November 2018, Greatgroup announced that it had entered into an unconditional agreement to sell 19.9% of its 21.8% shareholding in Stanmore to Golden Energy and Resources Limited ("GEAR"). That transaction completed on 5 December 2018.

Chairman, Mr Stewart Butel, acknowledged Mr McAuliffe and thanked him on behalf of the Board for his significant contribution to the Company over the past six years.

Golden Investments (Australia) Pte Ltd, a company owned by GEAR and Ascend Global Investment Fund SPC, announced an unsolicited, conditional takeover offer for the Company on 19 November 2018.

The Board has previously advised shareholders of its view that the takeover offer significantly undervalues the shares in Stanmore and has recommended that shareholders reject the offer. To reject the offer, shareholders should take no action.
