Company Report (Appendix 4C)

Enclosed is the Quarterly Report (Appendix 4C) for the 3 months ended 31 December 2018.

At 31 December 2018 the Company's cash balance was \$1,508,000 in funds with bank overdrafts undrawn. Total finance facilities available to the Company amount to \$3,500,000, inclusive of bank overdrafts of \$740,000 and term loan facilities of \$2,760,000.

The total cash balance increased by a net \$1,345,000 during the quarter.

Operating cash usage was a net \$1,767,000 inflow during the quarter, reflecting fluctuations in monthly trading activities and the timing of customer orders and payments. The Company received substantial revenue receipts as anticipated which more than offset the quarters operating and staff payments.

Investment activities amounted to a net cash outflow of \$422,000 over the quarter for continuing capitalized new product developments.

No further drawings on the term loan finance facility were required during the quarter.
