ISSUE OF SHARES FOLLOWING EXTRAORDINARY GENERAL MEETING (EGM)

Aeris Environmental Ltd (ASX:AEI) advises that today it has allotted 28,109,948 new fully paid ordinary shares, at \$0.17 per share, following shareholder approval at the EGM held on 29 January 2019. Details of the share issues are as follows:

- (a) 18,874,656 shares issued under a placement made to sophisticated and professional investors who were not related parties to the Company, which raised \$3,208,692 to fund Aeris' rapidly-growing American and global businesses, including meeting the costs associated with its entry into a strategic rollout internationally, and for corporate costs and working capital;
- (b) 8,823,528 shares split equally between three Directors, being 2,941,176 shares each, by way of settlement of amounts owing to them relating to loans they made to the Company for a total of \$1,500,000; and
- (c) 411,764 shares issued to the Company Secretary in lieu of fees for his services for a period of approximately 12 months from 1 December 2018, to be held in voluntary escrow until they are earned by him.
