Veriluma Limited (ASX: VRI, Veriluma or Company) one of Australia's leading Artificial Intelligence companies providing prescriptive software solutions is pleased to provide an update on its activities for the quarter ended 31 December 2018.

Operational Update

During the quarter, Veriluma continued discussions with various parties to trial our software and with partner organisations to include our software in their solutions to market. A proof of concept trial began with a leading international electronics and systems group and discussions around their expansion and rollout have begun.

Of note, following on from our tender submission, Veriluma entered negotiations with the Commonwealth. These negotiations are still proceeding. The market will be kept informed of developments at the appropriate time.

Veriluma is pleased to announce that a leading Australian university has purchased our software for use in a research project.

Corporate Update

The board continues to be focused on its core strategy where it sees Veriluma's greatest opportunity: Defence/National Security. The board is actively considering strategies to ensure the working capital needs of the Company are met.

Financial Overview

For the quarter, the Company's net operating cashflow was \$13,000, which included Cash Inflows of \$242,000 from the Research and Development Tax Incentive, and \$22,000 from Software Licences. Estimated cash outflow for the next quarter is \$354,000. The Company's cash position at 31 December 2018 (unaudited) was \$151,000.
