Share Appreciation Rights issued under the Plan are entitlements to acquire a number of Shares equal to the growth in the value of the underlying Shares (if any) upon satisfaction of the relevant vesting conditions and other terms and conditions determined by the Board under the Plan. These Share Appreciation Rights granted under the Plan are subject to the following vesting dates:

- Tranche 1 700,000 SARs will vest 1 March 2020;
- Tranche 2 700,000 SARs will 1 March 2021;
- Tranche 3 1,100,000 SARs will 1 March 2022.

SARs will only vest on the vesting dates if the employee remains employed by Paladin or a subsidiary of Paladin on the vesting Upon vesting of any Rights, participants will be issued with Shares equal to the value derived by multiplying the number of vested Rights exercised by the relative growth in share price over the deemed exercise price. Relative share price growth is determined by a comparison of the Paladin share price growth with a hurdle share price of 20 cents per share (calculated Volume weighted average price using (VWAP) of a Share for the five trading days before the date of exercise). Vested and exercised Share Appreciation Rights will be converted into Paladin ordinary shares. Unvested Share Appreciation Rights which do not meet the vesting conditions or are not exercised within the exercise period will automatically lapse.
