Request for Trading Halt

Pursuant to Listing Rule 17.1, Bionomics Limited (ASX: BNO) (OTCQX: BNOEF) requests a trading halt be granted by the Australian Securities Exchange with respect to its securities, commencing from the start of trading today.

The trading halt is requested to prevent trading of the Company's securities in an uninformed market and assist the Company to manage its continuous disclosure obligations pending an announcement regarding the results of its BNC210 clinical trial to treat Agitation in elderly patients.

Bionomics requests that the trading halt operates until an announcement is made or the commencement of trading on Wednesday 26 June 2019, whichever occurs first.

Bionomics is not aware of any reason why the trading halt should not be granted.
