These faster devices will complement Beam's range of Iridium products, including its highly popular Iridium GO!® satellite hotspot device.

Iridium's selection of Beam as a beta partner reflects Beam's successful 17-year track record in building fixed and mobile satellite communications devices for Iridium.

The Iridium Certus 9770 will provide data speeds of between 22kbps and 88kbps on Iridium's unique L-band network from anywhere in the world.

"This new breed of device is the start of a shift in what defines small-form-factor satellite communications technology," said Matt Desch, CEO of Iridium.

"These are highly mobile, lower-cost solutions that feature native IP technology at speeds capable of delivering a true internet, email, high-quality voice, photo and even some video capabilities."

It is anticipated that Beam's Iridium Certus 9770-based products will be in commercial production in Q1 FY2021.
