Damstra Holdings Limited (ASX: DTC) – Admission and Commencement of Official Quotation – Deferred Settlement Trading

Description

Damstra Holdings Limited ('DTC') is expected to be admitted to the Official List of ASX Limited ('ASX') tomorrow, Wednesday 16 October 2019.

Official quotation of DTC's ordinary fully paid shares is expected to commence at 12:00 PM AEDT on Wednesday, 16 October 2019 on a <u>deferred settlement basis</u>.

DTC raised \$49,321,500 pursuant to the offer under its replacement prospectus dated 30 September 2019 ('Replacement Prospectus') by the issue of 38,888,889 ordinary fully paid shares by DTC and the sale and transfer of 15,912,778 ordinary fully paid shares by Damstra SaleCo Limited at an offer price of \$0.90 per share.
