NOTICE OF ANNUAL GENERAL MEETING

Notice is given that the Annual General Meeting (**AGM** or **Meeting**) of shareholders of People Infrastructure Ltd (**People Infrastructure** or **Company**) will be held:

The Explanatory Memorandum accompanying this Notice of Meeting provides additional information on matters to be considered at the AGM. The Explanatory Memorandum, Entitlement to Attend and Vote section and Proxy Form are part of this Notice of Meeting.

CONSIDERATION OF REPORTS

The first item of business is to receive and consider the Financial Report, the Directors' Report, and the Independent Auditor's Report of the Company for the financial year ended 30 June 2019.

All shareholders can view the Company's Annual Financial Report which contains the Financial Report, the Directors' Report and the Independent Auditor's Report of the Company for the year ended 30 June 2019 on the Company's website at <https://www.peopleinfrastructure.com/>.

QUESTIONS AND COMMENTS

Following consideration of the Reports, the Chairman will give shareholders a reasonable opportunity to ask questions about, or comment on the management of the Company.

The Chairman will also give shareholders a reasonable opportunity to ask the Auditor questions relevant to:

- a. the conduct of the audit;
- b. the preparation and content of the Independent Auditor's Report;
- c. the accounting policies adopted by the Company in relation to the preparation of the financial statements; and
- d. the independence of the Auditor in relation to the conduct of the audit.

The Chairman will also give the Auditor a reasonable opportunity to answer written questions submitted by shareholders that are relevant to the content of the Independent Auditor's Report or the conduct of the audit. A list of relevant written questions submitted by shareholders will be made available at the start of the AGM and any written answer tabled by the Auditor at the AGM will be made available as soon as practicable after the Meeting.

ITEMS FOR APPROVAL

Resolution 1. Re-Election of Director – Glen Richards

To consider and, if thought fit, pass the following as an ordinary resolution of the Company:

That Glen Richards, who retires in accordance with clause 19.3 of the Company's Constitution and being eligible for re-election, is re-elected as a Director of the Company."

Resolution 2. Remuneration Report

To consider and if thought fit, pass the following as a non-binding ordinary resolution of the Company:

"That the Company's Remuneration Report for the financial year ended 30 June 2019, as set out in the Directors' Report, is adopted."

The Remuneration Report is contained in the 2019 Annual Financial Report (available at <https://www.peopleinfrastructure.com/>). Please note that, in accordance with section 250R(3) of the *Corporations Act 2001* (Cth) (**Act**), the vote on this resolution is advisory only and does not bind the Directors or the Company.

Voting Exclusion Statement

A vote on Resolution 2 must not be cast (in any capacity) by, or on behalf of, the following persons:

- a. a member of the Key Management Personnel (**KMP**) whose remuneration details are included in the 2019 Remuneration Report; or
- b. a closely related party of such a KMP (including close family members and companies the KMP controls).

However, a person described above may cast a vote on Resolution 2 as a proxy if the vote is not cast on behalf of a person described above and either:

- a. the proxy appointment is in writing that specifies the way the proxy is to vote (e.g. for, against, abstain) on the resolution; or
- b. the vote is cast by the chair of the Meeting and the appointment of the chair as proxy:
 - i. does not specify the way the proxy is to vote on the resolution; and
 - ii. expressly authorises the chair to exercise the proxy even if the resolution is connected directly or indirectly with the remuneration of a member of the KMP.

In accordance with section 250BD of the *Corporations Act 2001* (Cth), a vote must not be cast on Resolution 2 as a proxy by a member of the KMP at the date of the AGM, or a closely related party of those persons, unless it is cast as proxy for a person entitled to vote in accordance with their directions. This restriction on voting undirected proxies does not apply to the Chairman of the Meeting where the proxy appointment expressly authorises the Chairman of the Meeting to exercise undirected proxies even if the resolution is connected, directly or indirectly, with the remuneration of the KMP.

"Key management personnel" and "closely related party" have the same meaning as set out in the Act.

Resolution 3. Approval of Additional Share Issue Capacity under ASX Listing Rule 7.1A

To consider and, if thought fit, pass the following as a special resolution of the Company:

"That, pursuant to and in accordance with ASX Listing Rule 7.1A and for all other purposes, the Shareholders of the Company approve the issue of equity securities up to 10% of the issued capital of People Infrastructure Ltd (at the time of the issue) calculated in accordance with the formula prescribed

in ASX Listing Rule 7.1A.2 and on the terms and conditions described in the Explanatory Memorandum which forms part of the Notice of Meeting.”

Voting Exclusion Statement

In accordance with ASX Listing Rule 14.11, the Company will disregard any votes cast in favour of Resolution 3 by or on behalf of:

- a. any person who may participate in the 10% placement facility, or who will obtain a material benefit as a result of the proposed issue, except a benefit solely by reason of being a holder of ordinary securities in the Company; or
- b. an associate of those persons.

As at the date of this Notice of Meeting, the Company has no specific plans to issue securities under the 10% placement facility under ASX Listing Rule 7.1A and therefore it is not known who (if any) may participate in a potential issue of securities under the placement facility (if any) under ASX Listing Rule 7.1A. On that basis, the Company is not aware of any person who would be excluded from voting on this resolution.

However, the Company need not disregard a vote cast on Resolution 3 if:

- a. it is cast by a person as proxy for a person who is entitled to vote in accordance with the directions on the proxy form; or
- b. it is cast by the person chairing the Meeting as proxy for a person who is entitled to vote, in accordance with a direction on the proxy form to vote as the proxy decides.

Resolution 4. Ratification of issue of Shares to institutional, sophisticated and professional investors

To consider and, if thought fit, pass the following as an ordinary resolution:

*“That, for the purposes of ASX Listing Rule 7.4 and for all other purposes, the issue on 19 June 2019 of a total of 1,494,764 fully paid ordinary shares in People Infrastructure Ltd (**Shares**) at an issue price of \$2.70 per Share, on the terms and conditions set out in the Explanatory Memorandum accompanying this Notice, is ratified.”*

Voting Exclusion Statement

In accordance with ASX Listing Rule 14.11, the Company will disregard any votes cast in favour on Resolution 4 by or on behalf of:

- a. any person who participated in the above issue; or
- b. an associate of those persons.

However, the Company need not disregard a vote cast on Resolution 4 if:

- a. it is cast by a person as proxy for a person who is entitled to vote in accordance with the directions on the proxy form; or
- b. it is cast by the person chairing the Meeting as proxy for a person who is entitled to vote, in accordance with a direction on the proxy form to vote as the proxy decides.

Resolution 5. Issue of Rights under the 2017 Performance Rights Plan – Declan Sherman

To consider and, if thought fit, to pass the following as an ordinary resolution of the Company:

“That, for the purposes of ASX Listing Rule 10.14 and for all other purposes, the issue of 31,437 Performance Rights to Declan Sherman under the 2017 Performance Rights Plan on the terms described in the Explanatory Memorandum which forms part of the Notice of Meeting, is approved.”

Voting Exclusion Statement

In accordance with ASX Listing Rule 14.11, the Company will disregard any votes cast in favour of Resolution 5 by or on behalf of:

- a) Declan Sherman; or
- b) any associate of Declan Sherman.

Additionally, in accordance with listing rule 14.11 the Company will also disregard any votes cast in favour of Resolution 5 by or on behalf of:

- a) any Director of the Company who is eligible to participate in the *2017 Performance Rights Plan*; or
- b) an associate of any of those Directors.

However, the Company need not disregard a vote cast on Resolution 5 if:

- a. it is cast by a person as proxy for a person who is entitled to vote in accordance with the directions on the Proxy Form; or
- b. it is cast by the person chairing the Meeting as proxy for a person who is entitled to vote, in accordance with a direction on the Proxy Form to vote as the proxy decides.

In accordance with ASX Listing Rule 14.11, the Company will disregard any votes cast in favour of Resolution 6 by or on behalf of:

- c) Thomas Reardon; or
- d) any associate of Thomas Reardon.

Additionally, in accordance with listing rule 14.11 the Company will also disregard any votes cast in favour of Resolution 6 by or on behalf of:


- c) any Director of the Company who is eligible to participate in the *2017 Performance Rights Plan*; or
- d) an associate of any of those Directors.

However, the Company need not disregard a vote cast on Resolution 6 if:

- a. it is cast by a person as proxy for a person who is entitled to vote in accordance with the directions on the Proxy Form; or
- b. it is cast by the person chairing the Meeting as proxy for a person who is entitled to vote, in accordance with a direction on the Proxy Form to vote as the proxy decides.

In addition, and in accordance with section 250BD of the Corporations Act 2001 (Cth), a vote must not be cast on Resolution 6 as a proxy by a member of the KMP at the date of the Meeting, or a closely related party of those persons, unless it is cast as proxy for a person entitled to vote in accordance with their directions. ENTITLEMENT TO ATTEND AND VOTE

In accordance with regulation 7.11.37 of the Corporations Regulations 2001 (Cth), the Board has determined that persons who are registered holders of shares of the Company as at 7:00pm (Brisbane time) on Sunday 24 November 2019 will be entitled to attend and vote at the AGM as a shareholder.

If more than one joint holder of shares is present at the AGM (whether personally, by proxy or by attorney or by representative) and tenders a vote, only the vote of the joint holder whose name appears first on the register will be counted.

Appointment of Proxy

If you are a shareholder entitled to attend and vote, you may appoint an individual or a body corporate as a proxy. If a body corporate is appointed as a proxy, that body corporate must ensure that it appoints a corporate representative in accordance with section 250D of the Corporations Act 2001 (Cth) (the **Act**) to exercise its powers as proxy at the AGM.

A proxy need not be a shareholder of the Company.

A shareholder may appoint up to two proxies and specify the proportion or number of votes each proxy may exercise. If the shareholder does not specify the proportion or number of votes to be exercised, each proxy may exercise half of the shareholder's votes.

To be effective, the proxy must be received at the Share Registry of the Company no later than 11.00am (Brisbane time) on Sunday 24 November 2019 (48 hours before AGM). Proxies must be received before that time by one of the following methods:

To be valid, a proxy form must be received by the Company in the manner stipulated above. The Company reserves the right to declare invalid any proxy not received in this manner.

Power of Attorney

A proxy form and the original power of attorney (if any) under which the proxy form is signed (or a certified copy of that power of attorney or other authority) must be received by the Company no later than 11.00am (Brisbane time) on Sunday 24 November 2019, being 48 hours before the AGM.

Corporate Representatives

A body corporate which is a shareholder, or which has been appointed as a proxy, is entitled to appoint any person to act as its representative at the AGM. The appointment of the representative must comply with the requirements under section 250D of the Act. The representative should bring to the AGM a properly executed letter or other document confirming its authority to act as the company's representative. A "Certificate of Appointment of Corporate Representative" form may be obtained from the Company's share registry or online at www.linkmarketservices.com.au.

IMPORTANT: If you appoint the Chairman of the Meeting as your proxy, or the Chairman becomes your proxy by default, and you do not direct your proxy how to vote on Resolutions 2, 5 and 6, then by submitting the proxy form you will be expressly authorising the Chairman to exercise your proxy on the relevant resolution, even though the resolutions are connected, directly or indirectly, with the remuneration of the KMP.

EXPLANATORY MEMORANDUM

This Explanatory Memorandum has been prepared for the information of shareholders of the Company (**Shareholders**) in relation to the business to be conducted at the Company's AGM to be held on Tuesday 26 November 2019.

The purpose of this Explanatory Memorandum is to provide Shareholders with information that is reasonably required by Shareholders to decide how to vote upon the resolutions.

Subject to the abstentions noted below, the Directors unanimously recommend Shareholders vote in favour of all Resolutions. The Chairman of the Meeting intends to vote all available undirected proxies in favour of each resolution.

Resolutions 1, 4, 5 and 6 are ordinary resolutions, which require a simple majority of votes cast by Shareholders present and entitled to vote on the resolution. Resolution 2 relating to the Remuneration Report, is advisory and does not bind the Directors or the Company. Resolution 3 is to be voted on as a special resolution. For a special resolution to be passed, at least 75% of the votes cast by Shareholders present and entitled to vote on the resolution must be in favour of the resolution.

Resolution 1. Re-Election of Director – Glen Richards

Glen Richards was appointed as an independent non-executive Director of the Company on 18 October 2017. In accordance with clause 19.3 of the Constitution, Glen Richards retires from office at the conclusion of the AGM and is eligible for re-election as a Director of the Company.

Glen Richards is the Chair of the Company's Audit and Risk Committee and member of the Company's Nomination and Remuneration Committee.

Glen Richards (Qualifications: B.V.Sc.(Hons), M.Sc., F.A.I.C.D.) has over 27 years of experience in the retail and professional services sectors with extensive operational experience in fast growing companies, especially in health care and allied health sectors. Dr Richards was the founding Managing Director of Greencross Limited and Co-Founder of Mammoth Pet Holdings Pty Ltd, prior to its merger with Greencross Limited in 2014. He is currently Chairman of Healthia Limited, Naturo Pty Ltd and Cardionexus Holdings Pty Ltd, and a non-executive director of Regeneus Ltd and Adventure Holdings Australia Pty Ltd. Dr Richards is also a shareholder, advisor and mentor of a number of innovative technology companies.

Prior to Glen Richards' appointment as a director in 2017, the Company completed several background and screening checks including in relation to Glen Richards' character, experience and qualifications, criminal history, bankruptcy with no adverse findings. The Board considers that Glen will, if re-elected, qualify as an independent director.

The Directors, with Glen Richards abstaining, unanimously recommend Shareholders vote in favour of Resolution 1.

Resolution 2. Remuneration Report

Section 250R(2) of the Corporations Act 2001 (Cth) (the **Act**) requires that the section of the Directors' Report dealing with the remuneration of directors and key management personnel (**KMP**) of the Company (**Remuneration Report**) be put to the vote of shareholders for adoption by way of a non-binding vote. The vote on this resolution is advisory only and does not bind the Directors or the Company. However the Board will take the outcome of the vote into account in setting remuneration policy for future years.

Broadly, the Remuneration Report details the remuneration policy for the Company and:

- explains the structure of and rationale behind the Company's remuneration practices and the link between the remuneration of executives and the Company's performance;
- sets out remuneration details for each Director and for each executive with authority and responsibility for directing the affairs of the Company; and

- discusses the relationship between the policy and Company performance.

Shareholders can view the full Remuneration Report in the Annual Financial Report which is available on People Infrastructure's website at <https://www.peopleinfrastructure.com>.

Following consideration of the Remuneration Report, the Chairman of the Meeting will give shareholders a reasonable opportunity to ask questions about, or make comments on, the Remuneration Report.

The Directors abstain, in the interests of good corporate governance, from making a recommendation in relation to Resolution 2.

Resolution 3. Approval of Additional Share Issue Capacity under ASX Listing Rule 7.1A

ASX Listing Rule 7.1A enables mid to small cap listed companies to seek shareholder approval by special resolution to issue equity securities equivalent to an additional 10% of the number of ordinary securities on issue by way of placement over a 12 month period (**10% Placement Facility**). This is in addition to the existing 15% placement capacity permitted by ASX Listing Rule 7.1.

A company is eligible to seek shareholder approval for this additional placement capacity if it satisfies both of the following criteria at the date of its annual general meeting:

- it has a market capitalisation of \$300 million or less; and
- it is not included in the S&P/ASX 300 Index.

The Company currently satisfies both the above criteria, and it is anticipated that it will satisfy both these criteria at the date of its annual general meeting.

Accordingly, Resolution 3 is seeking approval of ordinary Shareholders by special resolution for the issue of such number of equity securities as calculated under the formula in ASX Listing Rule 7.1A.2, at an issue price as permitted by ASX Listing Rule 7.1A.3 to such persons as the Board may determine, on the terms as described in this Explanatory Memorandum.

At the date of this Notice, the Company has on issue 72,516,111 fully paid ordinary shares.

If Resolution 3 is passed, the exact number of equity securities that the Company will have capacity to issue under ASX Listing Rule 7.1A will be calculated at the date of issue of the equity securities in accordance with the following formula prescribed in ASX Listing Rule 7.1A.2 (which at the date of this Notice is):

(A x D) – E

Where:

- A** is the number of fully paid Shares on issue 12 months before the issue date or date of agreement to issue:
- plus the number of fully paid Shares issued in the 12 months under an exception in Listing Rule 7.2;
 - plus the number of partly paid Shares that became fully paid in the 12 months;
 - plus the number of fully paid Shares issued in the 12 months with approval of holders of Shares under Listing Rule 7.1 or 7.4. This does not include an issue of fully paid Shares under the entity's 15% capacity pursuant to Listing Rule 7.1 without Shareholder approval; and
 - less the number of fully paid Shares cancelled in the 12 months.

D is 10%.

E is the number of equity securities issued or agreed to be issued under Listing Rule 7.1A.2 in the 12 months before the issue date or date of agreement to issue that are not issued with the approval of Shareholders under Listing Rule 7.1 or 7.4.

The effect of Resolution 3 will be to allow the Directors to issue a further 10% of equity securities under ASX Listing Rule 7.1A during the 12 month period following the 2019 AGM, in addition to the Company's 15% placement capacity under ASX Listing Rule 7.1.

Information required by ASX Listing Rule 7.3A

For the purposes of ASX Listing Rule 7.3A, the following information is provided:

- The minimum price at which the equity securities will be issued will be no less than 75% of the volume weighted average price for ordinary shares calculated over the 15 trading days on which trades are recorded immediately before:
 - a. the date on which the price at which the securities are to be issued is agreed; or
 - b. if the securities are not issued within 5 trading days of the date in paragraph a., the date on which the securities are issued.
- If Resolution 3 is approved by Shareholders and the Company issues equity securities under the 10% Placement Facility, the existing ordinary Shareholders face the risk of economic and voting dilution, including the risk that:
 - a. the market price of equity securities in that class may be significantly lower on the issue date than on the date on which this approval is being sought; and
 - b. the equity securities may be issued at a price that is at a discount to the market price for those equity securities on the issue date,

which may have an effect on the amount of funds raised by the issue of the equity securities and the nature of the dilution impact on shareholders.

- As required by Listing Rule 7.3A.2, the following table gives examples of the potential dilution of existing ordinary Shareholders on the basis of the current market price of shares as at close of trade on 2 October 2019 and the current number of ordinary securities for variable "A", calculated in accordance with the formula in ASX Listing Rule 7.1A.2.

The table also shows:

- a. two examples where variable "A" has increased by 50% and 100%. Variable "A" is based on the number of ordinary securities the Company has on issue. The number of ordinary securities on issue may increase as a result of issues of ordinary securities that do not require Shareholder approval (for example, a pro rata entitlements issue or scrip issued under a takeover offer) or future specific placements under ASX Listing Rule 7.1 that are approved at a future Shareholders' meeting. It is important to note that the exact number of securities which may be issued under the 10% Placement Facility (if Resolution 3 approved) will be calculated in accordance with the formula contained in Listing Rule 7.1A.2; and
- b. two examples of where the issue price of ordinary securities has decreased by 50% and increased by 100% as against the current market price at 2 October 2019.

- The table has been prepared on the following assumptions:
 - a. the Company issues the maximum number of equity securities available under the 10% Placement Facility in ASX Listing Rule 7.1A;
 - b. no unquoted Options or Performance Rights (including any Options or Performance Rights issued under the 10% placement facility) are exercised before the date of issue of ordinary shares under ASX Listing Rule 7.1A;
 - c. the 10% voting dilution reflects the aggregate percentage dilution against the issued share capital at the time of issue. This is why the voting dilution is shown in each example as 10%;
 - d. the table does not show an example of dilution that may be caused to a particular shareholder by reason of issues under the 10% Placement Facility, based on that shareholder's holding at the date of the AGM;

Resolution 3 is a special resolution. For a special resolution to be passed, at least 75% of the votes cast by Shareholders present and entitled to vote on the resolution must be in favour of the resolution.

The Directors unanimously recommend Shareholders vote in favour of Resolution 3.

Resolution 4. Ratification of issue of Shares to institutional, sophisticated and professional investors

Background about the Placement

On 13 June 2019, the Company announced details of a Placement to domestic and international institutional and sophisticated investors to subscribe for 7,407,408 new ordinary shares in the Company at a price of A\$2.70 cents per share, to raise approximately A\$20 million (**Placement**).

Of the 7,407,408 new Placement shares that were issued, 1,494,764 shares were issued under the Company's ASX Listing Rule 7.1 capacity, with the remaining 5,912,644 Placement Shares issued under the ASX Listing Rule 7.1A capacity obtained at the 2018 AGM.

Listing Rule 7.4 permits the ratification of previous issues of securities made without prior Shareholder approval, provided the issue did not breach the 15% threshold set by Listing Rule 7.1. The effect of the ratification is to restore the Company's maximum discretionary power to issue further Shares up to 15% of the issued capital of the Company without requiring Shareholder approval.

Under Resolution 4, the Company is seeking shareholder ratification pursuant to Listing Rule 7.4 of the issue of 1,494,764 fully paid ordinary Shares on 19 June 2019 to institutional, sophisticated and professional investors under the Placement announced to the ASX on 13 June 2019 in order to restore the ability of the Company to issue further Shares within the 15% limit during the next 12 months.

Additional information required by ASX Listing Rule 7.5

The following information in relation to the Shares is provided to Shareholders for the purposes of Listing Rule 7.5:

- 1,494,764 Shares were issued;
- the Shares were issued at an issue price of \$2.70 each;

- A voting exclusion statement is set out under Resolution 4 in the Notice of Meeting.

The Directors unanimously recommend Shareholders vote in favour of this Resolution 4.

Resolutions 5 and 6. Issue of Rights under the 2017 Performance Rights Plan – Declan Sherman and Thomas Reardon

Please refer to the Company's Remuneration Report in the 2019 Annual Financial Report for details on the Company's approach to Remuneration which includes fixed and at risk remuneration.

These resolutions deal with the proposed grant of performance rights (**Rights**) under the 2017 Performance Rights Plan (**Plan**) to Declan Sherman, Managing Director of the Company and Thomas Reardon, Executive Director of the Company to acquire fully paid ordinary shares in the Company under the Plan. The Company has agreed, subject to obtaining shareholder approval to grant a total of 31,437 Rights to each of:

- Declan Sherman; and
- Thomas Reardon.

The ASX Listing Rules (**Listing Rules**) and the Act set out a number of regulatory requirements which must be satisfied. These are summarised below.

Listing Rule 10.14 requires the approval of ordinary shareholders to issue securities under an employee incentive scheme, such as the Plan to a Director of the Company. Accordingly, approval for the grant of the Rights to Declan Sherman and Thomas Reardon is required under Listing Rule 10.14. Approval of these resolutions will result in the grant of Rights to Declan Sherman and Thomas Reardon. Once approval is obtained under Listing Rule 10.14, the Company is entitled to rely on Listing Rule 10.12 (Exception 4) in relation to any requirement requiring shareholder approval under Listing Rule 10.11. In addition, Exception 14 in ASX Listing Rule 7.2 provides that ASX Listing Rule 7.1 does not apply where shareholder approval for an issue of securities is obtained under ASX Listing Rule 10.14. This means that, if shareholder approval is obtained for Resolutions 5 and 6, approval is not required for the purposes of ASX Listing Rule 7.1.

Chapter 2E of the Corporations Act regulates the provision of financial benefits to related parties by a public company. The issue of Rights to Declan Sherman and Thomas Reardon contemplated by Resolutions 5 and 6 constitutes the provision of a financial benefit to a related party. The Board has formed the view that Shareholder approval under Chapter 2E of the Corporations Act is not required because the issue of Rights to Declan Sherman and Thomas Reardon reflects the provision of reasonable remuneration for the purposes of section 211 of the Corporations Act, and accordingly the Company will not also seek approval for the issue of the Rights pursuant to section 208 of the Corporations Act.

Purpose of the Plan

The Plan was established by the Company prior to its IPO and admission to the ASX in 2017. A summary of the terms of the Plan was set out in the Company's Prospectus dated 20 October 2017 (**Prospectus**).

The Company has established the Plan to assist in the motivation, retention and reward of Eligible Participants as defined under the Plan. The Plan is designed to align the interests of Eligible Participants with Shareholders by providing an opportunity for the Eligible Participants to receive an equity interest in the Company.

Calculation of the Proposed Number of Rights

The number of Rights to be granted to each of Declan Sherman and Thomas Reardon has been calculated by taking \$105,000 and dividing that by the share price on the last day of the 2019 financial year of the Company (which was \$3.34).

It is proposed that each of Declan Sherman and Thomas Reardon be granted 31,437 Rights. The date of the proposed grant is 26 November 2019, and is subject to shareholder approval at the AGM (**Grant Date**).

The Rights will be granted to Declan Sherman and Thomas Reardon for nil financial consideration.

Vesting Conditions

The vesting conditions are based on an earnings per share (**EPS**) performance hurdle, tested based on the compound annual growth rate (**CAGR**) of the Company's EPS over the four-year period commencing 26 November 2019 and ending on 26 November 2023 (**Performance Period**) (**EPS Hurdle**).

The Rights will vest equally over FY20, FY21, FY22 and FY23 (each a **Vesting Period**):

- 50% of the Performance Rights in any given Vesting Period will vest if CAGR of total shareholder return and earnings per share growth (**Growth Metric**) over the relevant Vesting Period is greater than 10%; and
- a further 50% vest if the Growth Metric, over the relevant Vesting Period is greater than 15%.

Each of Declan Sherman and Thomas Reardon will be offered the following Rights:

Number of Rights Offered	31,437, in the follow tranches: (a) 7859 (T1 Rights); and (b) 7859 (T2 Rights); and (c) 7859 (T3 Rights); and (d) 7860 (T4 Rights).

Additional Terms of the Rights

- Rights do not carry any dividend or voting rights prior to vesting.
- A grant of Rights does not confer any right or interest, whether legal or equitable, in Shares until all Vesting Conditions in respect of such Rights have been satisfied or waived by the Board.
- The Plan contains provisions specifying, that while Rights held by a Eligible Participant are subject to Vesting Conditions which have not been satisfied or waived, if:
 - those Rights have not become Vested Rights (as defined in the Plan) by the end of the applicable Vesting Period or the Board determines that the Vesting Conditions are incapable of being satisfied by the end of the Vesting Period, the Participant shall forfeit any right or interest in the Rights; or
 - the Board determines that the Eligible Participant has committed any act of fraud or gross misconduct, or such other circumstances occur as may be specified in the Offer, in relation to the affairs of the Company or a Related Company, the Eligible Participant shall forfeit any right or interest in the Rights or other entitlements of the Eligible Participant under the Plan (**Forfeiture Events**).
- The Rights will vest in four tranches over a four year period from the Grant Date in the following proportions:
 - Year 1 – 25%
 - Year 2 – 25%

- Performance will be tested at the end of each Vesting Period (in years 1, 2, 3 and 4) to determine the extent to which the Company has satisfied the Growth Metric performance condition.

- Unless the Board decides otherwise, if a Change in Control (as defined in the Plan) occurs all Vesting Conditions applicable to Unvested Rights (as defined in the Plan) will be waived.
- Unless otherwise determined by the Board at its discretion, Rights which have not been exercised will expire and cease to exist on the first to occur of:
 - either Declan Sherman or Thomas Reardon cease to be employed by the Company or a Related Company (as applicable in relation to their individual Rights);
 - the Rights being forfeited upon the occurrence of a Forfeiture Event under the Plan rules (as detailed above); and
 - the fifth anniversary of the Time of Grant (as defined in the Plan), unless the Board in its discretion has determined at the Time of Grant that another expiry date is to apply to the Right.
- If there is a reconstruction of the issued capital of the Company (including consolidation, subdivision, reduction or return), the number of Shares to be delivered in respect of each Right, the amount payable (if any) by a Participant in respect of Shares to be delivered, or both, will be adjusted to the extent necessary to comply with the Listing Rules applying to a reorganisation of capital.

- Declan Sherman and Thomas Reardon are both Executive Directors of the Company.
- The number of Rights to be awarded to each of Declan Sherman and Thomas Reardon, being 31,437, has been calculated by taking \$105,000 and dividing that by the share price on the last day of the 2019 financial year of the Company (which was \$3.34). The Rights will be granted for nil financial consideration.
- Under the terms of the Plan, all Executive Directors are entitled to participate in the Plan, being Declan Sherman and Thomas Reardon.
- Other than in respect of the initial Rights which were issued to Declan Sherman and Thomas Reardon prior to the Company's listing on the ASX (as disclosed in the Prospectus) and the 119,375 Rights issued to Declan Sherman and the 119,375 Rights issued to Thomas Reardon that were approved at the 2018 AGM, no further Rights have been issued to Declan Sherman, Thomas Reardon or any other persons referred to in Listing Rule 10.14 since the Plan was established.
- A voting exclusion statement is set out under Resolution 5 and Resolution 6 in the Notice of Meeting.
- There is no loan attaching to the award under the Plan.
- Subject to approval being obtained, the Company is expected to award the Rights shortly after the AGM but in any event no later than 12 months after the AGM.

The Directors (apart from Declan Sherman (for Resolution 5) and Thomas Reardon (for Resolution 6)), who do not have an interest in the outcome of the relevant resolution, unanimously recommend that Shareholders vote in favour of these Resolutions for the reasons set out below:

- *The Directors consider that it is important for the Company to be able to attract and retain experienced Directors and that the proposed grant of Rights to each of Declan Sherman and Thomas Reardon is appropriate taking into account their level of experience and contribution to the Company.*
- *The Directors consider that the proposed number of Rights to be granted to each of Declan Sherman and Thomas Reardon is appropriate to:*
 - *Motivate each of Declan Sherman and Thomas Reardon to pursue long-term growth and success of the Company (within an appropriate control framework);*
 - *Align the interests of key leadership with the long-term interests of the Company's shareholders; and*
 - *Ensure a clear correlation between performance and remuneration, in accordance with the Company's remuneration policy.*

- *The ASX Corporate Governance Council's Corporate Governance Principles and Recommendations (3rd edition) note that equity-based remuneration can be an effective form of remuneration for executives.*
