## Chairman's address

### EML's 2019 Annual General Meeting

2019 has been a fantastic year for EML. In addition to what I said in my letter to shareholders contained in the Annual Report, I'd like to say a few short words about:

- The year we have had
- The exciting acquisition that we announced on Monday
- The fantastic team that we have at EML.

Some of our headlines for 2019 include:

- Seven years of continuous growth – which is an incredible achievement.
- That growth has come both organically – and is a testament to the effort and energy of our employees.
- And through acquisitions – Tom and the team have worked incredibly hard at identifying the right acquisitions and then executing on them.
- During FY19 we welcomed two new businesses into our fold: First, PerfectCard our Irish based subsidiary which holds our eMoney licence.
- Second, Flex-e-Card based in the UK, but which has customers throughout Europe and the United Arab Emirates.
- In Australia we grew the business organically, including a major new contract with Smartgroup in the Salary Packaging space.

I wanted to touch very briefly on the acquisition we announced on Monday. Which is significant. The details are in the Investor Presentation lodged with the ASX, but if I could just make the following observations:

- Prepaid Financial Services, PFS, represents a wonderful opportunity for EML.
- It adds strength to our GPR business and provides us with the ability to provide Banking as a Service to the Fintech sector and digital banks.
- Like EML, PFS has a history of innovation and strong growth.
- Like EML, PFS has strong relationships.
- Like EML, PFS has historically delivered strong growth. We think it delivers a platform for future growth too.

Finally, I'd like to say thank you to the whole of our EML team. People are integral to our business. The culture of our people, and their commitment to our goals and vision is first rate.
