IMEXHS announces new contract with AI-RAD

HIGHLIGHTS

- 7-year Platform as a Service (PaaS) contract with existing radiology services customer, AI-RAD
- Total Contract Value (TCV) of US\$2.4 million (~A\$3.5 million)
- New contract brings company Annualised Recurring Revenue (ARR) to ~A\$8.6 million
- Equipment costs to be externally financed

SYDNEY — **26 November 2019** — Australian medical imaging company IMEXHS Limited [ASX: IME] ("IMEXHS" or "the Company") announces that it has signed a contract with radiology services provider AI-RAD S.A.S. ("AI-RAD") to provide additional equipment and software for their operations in Colombia. The Platform as a Service (PaaS) contract has a term of 7 years and a total contract value (TCV) of US\$2.4million (~A\$3.5 million), payable on a monthly basis.

AI-RAD is an existing customer of IMEXHS and the counterparty to the largest contract to date, with operations involving all major modalities (such as X-Ray, PET, CT, ultrasound, etc). The new software and equipment installation are an integral part of planned business expansion by the customer.

The new contract provides for the supply of HIRUKO together with six modalities. The contract requires a total capital expenditure of \$1.074m, with the majority of the equipment (77%) being financed by the external equipment vendor at 12% per annum repayable over three years and the remainder financed by existing credit lines. At the end of the seven-year contract period, the ownership of the equipment will transfer to AI-RAD.

IMEXHS CEO Dr German Arango said, "This further contract with AI-RAD is significant for IMEXHS as it validates the benefits of the HIRUKO solution and reinforces the strong working relationship we have built over the past 12 months. We look forward to continuing to work with AI-RAD, as they realise the high productivity that can be achieved through using HIRUKO and the enabling role it plays in the growth of their business.
