## **Results of Annual General Meeting**

In accordance with Listing Rule 3.13.2 and section 251AA of the Corporations Act 2001, Donaco International Limited advises details of the outcome of each resolution, and the proxies received in respect of each resolution, at today's Annual General Meeting.

The Board notes that as a result of today's AGM, three independent non-executive directors have been removed from the Board. The Board accepts the decision of the meeting, and wishes the new Board every success in serving the best interests of all shareholders.

Full details of the instructions given to validly appointed proxies in relation to each resolution, and the final results of the poll on each resolution, are set out in the attached document.

#### **Item 2 - Remuneration Report**

The motion was carried as an ordinary resolution on a poll.

The instructions given to validly appointed proxies in respect of the resolution were 84.6% in favour of the resolution. The final results of the poll were 91.6% in favour of the resolution.

Accordingly the Company has not incurred a "second strike" on the remuneration report, as only 8.4% of eligible votes were against the report.

#### Item 3 - Election of Director - Mr David Green

The motion was lost as an ordinary resolution on a poll.

The instructions given to validly appointed proxies in respect of the resolution were 80.2% in favour of the resolution.
