

# Apollo Tourism & Leisure Ltd Trading update

Apollo Tourism & Leisure Ltd (ASX: ATL) ('Apollo', or 'the Company') provides the following trading update given the unprecedented bushfire situation across Australia and its impact on the Company and its guests.

As we monitor the bushfire situation our immediate thoughts are with the communities and families affected by these events.

Guest safety is paramount and our operational focus in recent weeks has been on ensuring our valued guests stay safe and continue to enjoy their Australian RV holiday adventure in areas unaffected by the fires.

Via our telematics solution, we have been able to establish geo-fencing around affected regions. This is being closely monitored and updated as the situation evolves. We are attempting to contact any guest entering a geo-fenced area to ensure they are safe and are aware of the current situation. Information is also being made available to our guests on vehicle collection. This includes government websites to consult for planned travel routes along with recommendations to follow the advice of local authorities and listen to local radio stations for regular updates.

Domestic last-minute bookings over the peak summer holiday period have been impacted by the bushfires. The global media reporting of the Australian bushfires will also impact forward bookings.

The extent of the impact from the bushfire situation on Australian rental bookings into H2 FY20 is unclear at this stage. However, any negative impact on H2 FY20 bookings, combined with the reduction in last minute summer bookings in Australia and the, although improving, global RV sales markets remaining subdued, will make it challenging for the Company to reach the underlying FY19 net profit of \$14.7m in FY20. A further update will be provided with the Group's half year results, to be announced on Tuesday 25 February 2020.
