Cleansing statement

Friday 28 February 2020: Further to the Company's previous announcement dated 27 February 2020 in respect of the acquisition of Applied Project Experience Pty Ltd, Damstra Holdings Limited (the "**Company**", ASX: DTC) advises that today it has issued 2,054,793 fully paid ordinary shares in the Company ("**Shares**").
