SomnoMed Limited Entitlement Offer – Notification to ineligible shareholders

On Wednesday, 25 March 2020, SomnoMed Limited ACN 003 255 221 (ASX: SOM) (**Company**) announced a fully underwritten accelerated non-renounceable pro rata entitlement offer to eligible shareholders to subscribe for 1 new fully paid ordinary share in the Company (**New Share**) for every 3.24 existing fully paid ordinary shares in the Company (**Shares**) held as at 7.00 pm (Sydney, Australia time) on the record date (being, Friday, 27 March 2020) (**Record Date**) (**Entitlement**) at an issue price of \$0.80 per New Share (**Offer Price**) (**Entitlement Offer**).

The Entitlement Offer comprises an institutional component (**Institutional Entitlement Offer**) and an offer b Eligible Retail Shareholders (as defined below) to participate on the same terms (**Retail Entitlement Offer**). On Thursday, 26 March 2020, the Company announced that it had successfully raised approximately \$9.7 million under the Institutional Entitlement Offer. The Retail Entitlement Offer is non-renounceable, and Entitlements that are not taken up by Eligible Retail Shareholders, together with the Entitlements of Ineligible Retail Shareholders (as defined below), will lapse.

The Entitlement Offer is being made by the Company in accordance with section 708AA of the *Corporations Act* 2001 (**Corporations Act**) as modified by the Australian Securities and Investments Commission Corporations (Non-Traditional Rights Issues) Instrument 2016/84. The Institutional Entitlement Offer and the Retail Entitlement Offer together will raise approximately \$15.5 million.

Documents relating to the Retail Entitlement Offer were lodged with the Australian Securities Exchange (**ASX**) today and are being mailed to Eligible Retail Shareholders.

This letter has been sent to you to inform you about the Retail Entitlement Offer and to explain why you will not be able to subscribe for New Shares under the Retail Entitlement Offer. This letter is not an offer to issue New Shares to you, nor an invitation for you to apply for New Shares. You are not required to do anything in response to this letter but there may be financial implications for you as a result of the Entitlement Offer that you should be aware of.

Details of the Retail Entitlement Offer

The Retail Entitlement Offer is being made to Eligible Retail Shareholders on the basis of 1 New Share for every 3.24 existing Shares held at 7.00 pm (Sydney, Australia time) on the Record Date, being Friday, 27 March 2020.

Eligibility criteria

The Company has determined, pursuant to section 9A(3) of the Corporations Act and Listing Rule 7.7.1(a) of the ASX Listing Rules, that it would be unreasonable to make offers to the Company's shareholders in all countries in connection with the Retail Entitlement Offer. Accordingly, in compliance with section 9A(3) of the Corporations Act and ASX Listing Rule 7.7.1(b), the Company wishes to inform you that it will not be extending the Retail Entitlement Offer to you and you will not be able to subscribe for New Shares under the Retail Entitlement Offer.

Shareholders who are eligible to participate in the Retail Entitlement Offer (**Eligible Retail Shareholders**) are those shareholders of the Company who:

- (a) are registered as a holder of Shares as at the Record Date, being 7.00pm (Sydney, Australia time) on Friday, 27 March 2020;
- (b) have a registered address on the Company's share register that is in Australia or New Zealand;
- (c) are not in the United States and are not acting for the account or benefit of a person in the United

States (to the extent such shareholders hold securities in the Company for the account or benefit of such persons in the United States);

- (d) other than those holders of Shares who have an address in Australia or New Zealand on the Company's share register, are eligible under all applicable laws to receive an offer under the Entitlement Offer without a prospectus, disclosure document, product disclosure statement or any lodgement, filing, registration or qualification; and
- (e) were not invited to participate, (other than as nominee in respect of other underlying holdings) in the Institutional Entitlement Offer and were not treated as an ineligible institutional shareholder (as defined in the Investor Presentation lodged with ASX on Wednesday, 25 March 2020 under the Institutional Entitlement Offer.

Shareholders who are not Eligible Retail Shareholders are ineligible retail shareholders and are consequently unable to participate in the Retail Entitlement Offer. The Company may (at its absolute discretion) extend the Retail Entitlement Offer to certain institutional shareholders in foreign jurisdictions who did not participate in the Institutional Entitlement Offer (subject to compliance with applicable laws).

Wilsons Corporate Finance Limited (who is also the underwriter for the purposes of the Entitlement Offer) (**Wilsons**) has been appointed by the Company to act as nominee for the purposes of section 615 of the Corporations Act to:

- (a) accept the New Shares which would otherwise have been available to ineligible shareholders had they been eligible to participate in the Entitlement Offer;
- (b) use its best endeavours to sell those New Shares; and
- (c) pay the proceeds of any sale of New Shares (less the subscription price and other costs) to the Company's share registry who will then distribute to ineligible shareholders in proportion to their shareholding in the Company at the Record Date.

The Company and Wilsons will not be liable for the failure of Wilsons to sell the New Shares or the failure to sell the New Shares at any particular price. There is no guarantee that any proceeds will be realised from the sale of New Shares that would otherwise have been offered to ineligible shareholders.

Non-renounceable offer

As the Retail Entitlement Offer is non-renounceable, entitlements in respect of the New Shares you would have been entitled to if you were an Eligible Retail Shareholder will lapse and you will not receive any payment or value for your entitlements in respect of any New Shares that would have been offered to you if you had been eligible. New Shares equivalent to the number of New Shares you would have been entitled to if you were an Eligible Retail Shareholder shares you would have been entitled to if you were an Eligible Retail Shareholder may be allocated to other Eligible Retail Shareholders who subscribe for New Shares in excess of their entitlement under the Retail Entitlement Offer.
