Secondary Trading Notice Pursuant to Section 708A(5)(e) of the Corporations Act

MMJ Group Holdings Limited (ASX:MMJ) ("MMJ" or the Company"), an Australian-listed company that specialises in managing a portfolio of investments along the cannabis value-chain, gives this notice pursuant to section 708A(5)(e) of the Corporations Act 2001 (Cth) ("Corporations Act").

On 23 March 2020 the Company announced that it proposed to issue 687,500 fully paid ordinary shares at 8 cents each in the capital of the Company ("Securities").

The Company advises that the Securities have been issued without disclosure to investors under Part 6D.2 of the Act (Refer attached Appendix 2A).

The Company, as at the date of this notice, has complied with:

- (a) the provisions of Chapter 2M of the Act as they apply to the Company; and
- (b) section 674 of the Corporations Act.

Other than as noted below, as at the date of this notice there is no information to be disclosed which is excluded information (as defined in section 708A(7) of the Corporations Act) that is reasonable for investors and their professional advisers to expect to find in a disclosure document.

At the date of this statement, no such evaluations are sufficiently certain or material to warrant disclosure to the market.
