InvoCare Limited (ASX:IVC) - Request for trading halt

Pursuant to ASX Listing Rule 17.1, InvoCare Limited (ASX:IVC) (**InvoCare**) requests a trading halt in respect of its ordinary shares (**Shares**) from commencement of trading today, Tuesday, 14 April 2020. In accordance with ASX Listing Rule 17.1, InvoCare provides the following information:

- a) The trading halt is requested pending an announcement by the Company to the market in connection with a capital raising, which comprises a fully underwritten institutional placement (**Placement**), and a follow-on share purchase plan (**SPP**);
- b) InvoCare requests that the trading halt remain in place until the earlier of:
 - i) commencement of trading on Wednesday, 15 April 2020; or
 - ii) the time at which InvoCare makes an announcement to the market regarding the outcome of the Placement; and
- a) InvoCare confirms that it is not aware of any reason why the trading halt should not be granted, or of any other information available at this stage that is necessary to inform the market about the trading halt.
