#### **EXPIRY OF LISTED OPTIONS**

This letter is intended to provide you key details regarding your listed options in Monash Absolute Investment Company Limited (ASX:MA1) (**MA1** or the **Company**) before they are due to expire on 15 May 2020.

Your options enable you to acquire one (1) new share in the Company for each option you hold at \$1.05 per share. This is a premium to the 14 April 2020 Share Price of \$0.825.

There is no requirement for Option Holders to convert any or all their options. Your board advises that if you would like to acquire new shares in MA1, you can acquire them on market at \$0.825 as at 14 April 2020, which is a discount to the option exercise price.

If at the expiry date of 15 May 2020, the MA1 share price is above the exercise price of \$1.05 per share, you may be able to acquire new shares in MA1 at a discount by exercising your options.
