Distribution agreement with All County Health Care Inc. broadens US footprint

- Distribution agreement secured with All County Health Care to promote and sell Prizma in the US
- All County is a Medicare certified provider of home-based health care solutions

Medical device and Telehealth company **G Medical Innovations (ASX: GMV) ("G Medical" or the "Company")** is pleased to advise that it has secured a distribution agreement ("Agreement") with a prominent US-based, Medicare certified home health company, All County Health Care Inc. (www.allcountyhealthcare.com) ("All County") to significantly expand its exposure in the United States market. The Agreement follows the overthe-counter ("OTC") approval for the Prizma being granted by the US Food and Drug Administration (refer to the ASX announcement on 8 April 2020).

All County is a large, privately held company, located in Lauderdale Lakes in Florida. It specialises in the provision of quality home-based healthcare services through the dispatch of medical professionals to patient's homes following a referral. All County aims to considerably reduce hospital readmissions through the provision of home-based care services.

The group has an extensive network of approximately 1,400 physicians throughout South Florida and regularly engages with hospitals and medical organisations in the region. All County has a sales team of seven highly experienced representatives that are tapped into an established local market.

Under the Agreement, All County will market and distribute G Medical's Prizma product in the United States and will also offer to customers certain additional Prizma related services for a fee. The Agreement does not provide for a minimum term and will continue in perpetuity. There are no minimum sales commitments under the Agreement.
