**RESTORX APPOINTED TO CHU RESTORATION SERVICES PANEL**

Johns Lyng Group (ASX:JLG) subsidiary RestorX has entered into a national Restoration Services Agreement with strata insurance specialist CHU.

Under the agreement, RestorX will be appointed to CHU's Restoration Services Panels in all territories with the exception of Queensland.

Effective from June 1 2020, the agreement is for an initial 12-month period and is expected to be renewed automatically for successive periods of 12 months.

CHU is an underwriting agency specialising in strata and community title insurance for properties such as apartments, units, villas and townhouses.

RestorX specialises in contents and structural remediation following fire, flood and other impact events, and also offers decontamination and hygiene cleaning services that have been in high demand during the COVID-19 pandemic.

The agreement is another significant step into the strata sector for Johns Lyng, following its existing insurance services partnership with CHU, and the acquisition of Bright & Duggan in 2019.

CEO Scott Didier said Johns Lyng had established a sound working relationship with CHU and extending that into restoration services was a good outcome for both parties.

"As we've grown our strata footprint, we've worked with clients to develop best practice protocols that ultimately improve outcomes for the client, and we're confident we'll see the benefits of that through this new agreement," Mr Didier said.

"CHU is a strata insurance specialist with over 40 years' experience in Australia, and with our growing presence in the strata sector we're pleased to be able to introduce our leading restoration services capability.

"It's particularly relevant in the current environment with RestorX registering a high level of demand in the wake of the COVID-19 crisis, for disinfecting and deep cleaning of buildings, facilities and surfaces.

"We're confident RestorX leading service offering will add real value to CHU's strata customers."
