Summary of Key Terms of Company's Executive Share Plan

The major long-term incentives (LTIs) for employees are related to equity granted to senior executives pursuant to the Company's Executive Share Plan.

Senior executives of the Company are invited to participate in the Company's Executive Share Plan on an annual basis.

The Remuneration Committee sets the overall quantum of shares to be issued and approves the allocation to individual on the basis of recommendations it receives from the CEO and the heads of regional and global departments.

The performance of the executive in the financial year gone by is an important factor which is taken into consideration in determining the allocation to each employee, however, the main criteria are the importance of the role an individual plays and his or her value to the future development of our company.

Shares are issued to the Employee Share Trust on behalf of senior employees.

Vesting conditions apply to units issued under the Company's Employee Share Trust and units vest progressively over a number of years.

Units vest progressively over periods of up to four years from the date of issue, so as to provide employees with a long-term incentive to continue to add value to the Company's operations and whilst they remain employed with SomnoMed.
