**FORM 604 – NOTICE OF CHANGE OF INTERESTS OF SUBSTANTIAL HOLDER**

**ARA INCREASES ITS INTEREST IN CROMWELL TO 26.68%**

- The ARA Group has increased its relevant interest in Cromwell Property Group to 26.68% following the acquisition of 67.5 million securities on-market at \$0.915 per Cromwell Security
- Upon the Proportional Offer opening, the ARA Group will increase the Offer price to \$0.92 per Cromwell Security and, in the absence of a competing proposal emerging, will not increase it further (**Final Offer Price**)
- The Final Offer Price represents a premium of 14.9% to the 30-day Volume Weighted Average Price (VWAP) prior to announcement of ARA's offer of \$0.80 adjusted for distributions paid during the period
- In accordance with section 671B(1)(b) of the Corporations Act, a notice of change in the ARA Group's substantial holding is enclosed

Further to the announcement this morning, ARA Asset Management Holdings Pte. Ltd. and its related entities (the **ARA Group**) is pleased to confirm it has now acquired an additional 67.5 million securities in Cromwell on-market at \$0.915 per Cromwell Security.

As such, the ARA Group's relevant interest in Cromwell has increased to 26.68% as set out in the substantial holding notice enclosed with this announcement.

The ARA Group is pleased to also confirm that the Final Offer Price under its proportional off-market offer to acquire 29% of Cromwell securities not currently owned by the ARA Group (the **Proportional Offer**) will be increased to \$0.92 per Cromwell Security upon the Proportional Offer opening.

The Final Offer Price is at a premium to Cromwell's trading prices prior to 23 June 2020 (**Announcement Date**) despite ongoing market volatility and represents a:

- 8.1% premium to the Distribution Adjusted<sup>1</sup> last close price of \$0.85 per Cromwell Security prior to the Announcement Date;
- 14.9% premium to the Distribution Adjusted VWAP of \$0.80 per Cromwell Security for the 30 trading days leading up to the Announcement Date; and
- 18.2% premium to the Distribution Adjusted VWAP of \$0.78 per Cromwell Security for the three months leading up to the Announcement Date.

As Cromwell's largest Securityholder with now **more than \$750 million** invested to date, the ARA Group remains aligned with all Cromwell Securityholders and wishes to see improvements in the governance and operations of Cromwell for the benefit of **ALL** Cromwell Securityholders.

It is critical that the Board of Cromwell is refreshed and a strategic review process is overseen by a Board with a proprietorial focus that is representative of Cromwell Securityholders who all have a common goal to maximise the value of their investment. This is in contrast to Cromwell's recent strategic review which was undertaken by external parties and overseen by the current Board comprising non-executive directors who collectively own less than 0.07% of Cromwell's Securities on issue.

The ARA Group intends to provide Cromwell Securityholders with further details regarding its Proportional Offer via a Supplementary Bidder's Statement.




