### Letter to Shareholders regarding 2020 AGM

#### Dear Shareholder,

In light of the restrictions on public gatherings and in line with temporary amendments to the Corporations Act in response to the COVID-19 pandemic, the Board of Directors of Bingo Industries Limited (**BINGO**) has decided to make some changes to the way the Annual General Meeting (AGM) is hosted this year. The safety of our shareholders, our employees and the broader community are key considerations for us. Accordingly, like many other companies, our 2020 AGM will be conducted as a virtual meeting.

#### **Virtual AGM**

A virtual AGM presents us with an opportunity to try something new. This year's AGM will be held on **Wednesday**, **11 November 2020** at **10.00am (AEDT)**. You will be able to participate in the AGM regardless of your location by simply logging in to the AGM page on our website (see further details below).

The virtual AGM will provide you with similar opportunities online as you would have attending the AGM in person. You will be able to view and listen to presentations from me and our Managing Director and CEO, Daniel Tartak, as well as submit questions and vote.

#### **Notice of Meeting**

The Notice of Meeting will be released online and emailed to shareholders on **Monday**, **12 October 2020**. In accordance with the relief provided by the Federal Treasurer in response to the COVID-19 pandemic, BINGO will not be mailing hard copies of the Notice of Meeting by post.
