Julian Lange has advised the Supervisory Board of his decision to resign as of the end of December this year in order to pursue new career opportunities outside of the Company.

Julian will continue to work for Marley Spoon on a consulting basis from his departure date to the end of September 2021, to effect an orderly handover of responsibilities.

A search is undertaken to find his replacement and the Company will inform the market when an appointment is made.
