Amendment to Appendix 2A issued on 4 August 2020

Ionic Rare Earths Limited (ACN 083 646 477) (ASX: IXR) (**Company**) advises that on 4 August 2020 it issued an Appendix 2A making an application for the listing of 93,000,000 fully paid shares resulting from:

1. The exercise of 10,000,000 Options expiring 31 July 2021, exercisable at \$0.0075 (IXRAA);
2. The exercise of 50,000,000 Options expiring 22 August 2022, exercisable at \$0.005 (IXRAA); and
3. 33,000,000 Performance Rights (IXRAF) meeting their vesting condition.

Unfortunately, the application incorrectly stated that 33,000,000 Performance Rights had met the vesting condition when, in fact, the number was 33,300,000. This resulted in the application for listing 93,000,000 fully paid shares being an error – the correct number should have been 93,300,000.

The attached Appendix 2A corrects the original 2A issued on 4 August 2020.
