### **Appendix 2A – New Issue of Stapled Securities**

Holders of 94.331 million stapled securities, or 48.19% of the stapled securities on issue at 30 June 2020, elected to participate in the Distribution Reinvestment Plan (DRP).

Based on the DRP price of \$4.83, the number of new securities that were issued was 2,040,563.

The DRP raised a net amount of \$9.858 million of new equity.
