The Board has considered the ongoing public health concerns related to the COVID-19 pandemic, the health and safety of our shareholders, our people and the community, and decided that SeaLink's 2020 AGM will be held fully online (virtually) instead of at a physical location. There will not be a physical venue for shareholders to attend.

Attached to and forming part of this Notice of Meeting are the Explanatory Notes that provide shareholders with background information and further details in understanding the reasons for and the effect of the Resolutions if approved.

This information is presented in accordance with the regulatory requirements of the *Corporations Act 2001* (Cth) (Corporations Act).

Shareholders and proxyholders who wish to participate in the AGM may do so online, which will allow shareholders and proxyholders to view a webcast, ask questions in writing and vote online. Persons registered as guests may also view the AGM webcast.

Proxy Voting and Proxyholder Participation

SeaLink encourages all shareholders to cast their votes at the meeting by appointing a proxy (preferably the Chair of the Meeting) ahead of the meeting by completing the Proxy Form accompanying the Shareholder Letter. The entitlement for Members to vote at the Meeting will be determined by reference to those persons on the register of Members as at 6.30 p.m. Adelaide time (ACDT) on Sunday 25th October, 2020. The Proxy Form and the power of attorney or other authority (if any) under which it is signed (or a certified copy) must be received by the Company at least 48 hours before the time for holding the Meeting (being no later than 4:00 p.m. Adelaide time (ACDT) on Sunday 25th October, 2020) at the Company's share registry, Boardroom Pty Ltd:

Ordinary Business of the Meeting

1. CONSIDERATION OF FINANCIAL STATEMENTS

To receive and consider the financial report, the Chair's report and the Auditor's report for the year ended 30th June 2020.

Each year, we are required to communicate information to shareholders, including annual reports, notices of meetings and other advices. The *Corporations Legislation Amendment (Simpler Regulatory System) Act 2007* provides us with the ability to make the annual financial report available on a website and provide a hard copy of the annual report only to those Members who elect to receive them in that form, subject to certain administrative requirements. 2. ADOPTION OF REMUNERATION REPORT

To consider and if thought fit to pass the following motion as a non-binding ordinary resolution:

"That the Remuneration Report, as set out in the Directors' Report for the Company and its controlled entities for the financial year ended 30th June 2020, be adopted".

Note: the vote on this resolution is advisory only and does not bind the Directors or the Company.

Voting Exclusion Statement for Resolution 2

In accordance with Section 250R(4) of the Corporations Act, the Company will disregard any votes cast (in any capacity) on Resolution 2 by any Key Management Personnel, the details of whose remuneration are included in the Remuneration Report, and any closely related party (as defined in the Corporations Act) (**Closely Related Party**) of such Key Management Personnel.

However, a person described above may cast a vote on Resolution 2 if the vote is not cast on behalf of a person described above and either:

- (a) the person does so as proxy appointed in writing that specifies how the proxy is to vote on the proposed resolution; or
- (b) the Chair of the Meeting is appointed as proxy and the Proxy Form does not specify the way the proxy is to vote on the resolution and expressly authorises the Chair to exercise the proxy even if the resolution is connected directly or indirectly with the remuneration of a member of the Key Management Personnel.

The Company need not disregard a vote if it is cast by the person chairing the Meeting as proxy for a person who is entitled to vote, in accordance with the stated voting intentions of the Chair of the Meeting.

3. ELECTION OF DIRECTOR - NEIL SMITH

To consider and if thought fit to pass the following motion as an ordinary resolution:

'To elect as a Director of the Company, Mr Neil Smith, who having been appointed as an addition to the Board since the last Annual General Meeting of the Company, resigns in accordance with clause 58.2 of the Company's Constitution and Listing Rule 14.4 and, being eligible, offers himself for election.'

4. ELECTION OF DIRECTOR - LANCE HOCKRIDGE

To consider and if thought fit to pass the following motion as an ordinary resolution:

'To elect as a Director of the Company, Mr Lance Hockridge, who having been appointed to fill a vacancy in the Board since the last Annual General Meeting of the Company, resigns in accordance with clause 58.2 of the Company's Constitution and Listing Rule 14.4 and, being eligible, offers himself for election.'

5. RE-ELECTION OF DIRECTOR – JEFFREY ELLISON

To consider and if thought fit to pass the following motion as an ordinary resolution:

'That Jeffrey Ellison, who retires in accordance with clauses 59.1 and 59.4 of the Company's Constitution and Listing Rule 14.4, be re-elected a Director of the Company'.

Explanatory Notes

The Explanatory Notes accompany the Notice of Annual General Meeting for SeaLink Travel Group Limited ACN 109 078 257 (**Company** or **SeaLink**) to be held on Tuesday, 27th October 2020 at 4;00 p.m., Adelaide time (ACDT) as a virtual meeting.

Information relevant to the business to be considered at the Annual General Meeting is provided in these Explanatory Notes and shareholders should read this document in full.

AGENDA ITEM 1. CONSIDERATION OF FINANCIAL STATEMENTS

The financial statements for consideration at the AGM are included in the Company's 2020 Annual Report, and consist of the financial statements of the Company for the financial year ended 30th June 2020, the notes to those financial statements, the Directors' Report, the Directors' Declaration and the auditor's report including their Independence Statement.

The 2020 Annual Report is available on SeaLink's website at <u>www.sealinktravelgroup.com.au_</u>and via <u>www.boardroomlimited.com.au/agm/sealink</u>

Neither the *Corporations Act 2001* (Cth) (**Corporations Act**) nor the Company's constitution requires the Members to vote on the financial statements or the accompanying reports. However, Members will be given the opportunity to raise questions or comments on the financial statements at the AGM using either the Lumi platform (if you are participating on your computer) or the Lumi AGM app (if you are participating on your mobile phone or device), or by lodging questions prior to the meeting via <u>www.boardroomlimited.com.au/agm/sealink</u> or email to <u>company.secretary@sealink.com.au</u>. In addition, Members will be given the opportunity to ask the Company's auditor, Ernst & Young, questions relevant to the conduct of the audit, the independence of the auditor, SeaLink's accounting policies and the preparation and content of the auditor's report.

AGENDA ITEM 2. ADOPTION OF REMUNERATION REPORT

The Remuneration Report contained in the 2020 Annual Report is required to be considered by Members in accordance with section 250R of the Corporations Act. The Remuneration Report, which details SeaLink's policy on remuneration of non-executive directors, executive directors and key executives is set out in the 2020 Annual Report.

The vote on the adoption of the Remuneration Report is advisory only and is not binding. However, the Board will consider the outcome of the vote and comments made by Members on the Remuneration Report at the Meeting when reviewing the Company's remuneration policies and practices.

Further, if 25% or more of votes that are cast are voted against the adoption of the Remuneration Report at two consecutive AGMs, Members will be required to vote at the second AGM on a 'Board spill resolution' to determine whether another meeting should be held within 90 days at which all of the Company's Directors (other than a Managing Director) must stand for re-election.

At the 2019 AGM, the Company's Remuneration Report for the year ended 30 June 2019 did not receive a 'no' vote of 25% or more.

There are restrictions on who can vote in respect of any resolution to approve the Remuneration Report. A vote on this resolution must not be cast, and the Company will disregard any votes cast (in any capacity), by or on behalf of the following persons:

- (a) a member of the Key Management Personnel (as disclosed in the Remuneration Report); or
- (b) a Closely Related Party of such a member.

However, a person described above may cast a vote on a resolution to approve the Remuneration Report if the vote is not cast on behalf of a person described above and either:

- (a) the person does so as proxy appointed in writing that specifies how the proxy is to vote on the proposed resolution; or
- (b) the Chair of the Meeting is appointed as proxy and the Proxy Form does not specify the way the proxy is to vote on the resolution and expressly authorises the Chair to exercise the proxy even if the resolution is connected directly or indirectly with the remuneration of a member of the Key Management Personnel.

Link between remuneration outcomes and performance

The Remuneration Report explains how SeaLink's performance for the 2020 financial year has driven remuneration outcomes for our key executives. During the year SeaLink has successfully completed the acquisition and integration of the Transit Systems Group, which has transformed SeaLink into an integrated, resilient, international multi-modal contracted transport business. This has been achieved during a period of unprecedented external events, including overcoming the challenges and impacts of both the devastating bushfires across much of Australia during the summer of 2019/2020 and, more recently, the COVID-19 pandemic. Further detail can be found in the 2020 Annual Report.

Directors' Recommendation

The Board recommends that shareholders vote in favour of the Remuneration Report. The Chair of the Meeting intends to vote undirected proxies in favour of Resolution 2.

Important information for Members:

In accordance with sections 250R(4) and (5) of the Corporations Act, the Chair will not vote any undirected proxies in relation to this resolution unless the Shareholder expressly authorises the Chair to vote in accordance with the Chair's stated voting intentions. Please note that if the Chair of the Meeting is your proxy (or becomes your proxy by default), by completing the Proxy Form accompanying the Shareholder Letter, you will expressly authorise the Chair to exercise your proxy on this resolution even though it is connected directly or indirectly with the remuneration of a member of Key Management Personnel for the Company, which includes the Chair. You should be aware that the Chair of the Meeting intends to vote undirected proxies in favour of the adoption of the Remuneration Report.

Alternatively, if you appoint the Chair as your proxy, you can direct the Chair to vote for or against or abstain from voting on Resolution 2 by marking the appropriate box on the Proxy Form.

As a further alternative, Shareholders can nominate as their proxy for the purposes of Resolution 2, a proxy who is not a member of the Company's Key Management Personnel or any of their Closely Related Parties. That person would be permitted to vote undirected proxies (subject to the Listing Rules).

AGENDA ITEM 3 - ELECTION OF NEIL SMITH

In accordance with clause 58.2 of the Company's Constitution, Mr Neil Smith who, having been appointed as an addition to the Board since the last Annual General Meeting of the Company, resigns and being eligible, offers himself for election.

Neil was one of the founding shareholders and the former Chairman of the Transit Systems Group prior to the acquisition by SeaLink. He has over 30 years of commuter transport operations experience. Neil commenced his career within the Sydney bus industry, before acquiring a number of bus operations in rural NSW and then Queensland. In 1995, Neil joined with Graham Leishman and Lance Francis to found Transit Systems and in 2013, was a founding shareholder of Tower Transit.

Neil was appointed as a director of the Company on completion of the acquisition of the Transit Systems Group by SeaLink, which occurred on 16 January 2020. As noted in the Explanatory Memorandum lodged with the ASX on 8 November 2019 in connection with that acquisition, for a period of four years from 16 January 2020 and for so long as Neil directly or indirectly holds more than 15% of SeaLink's shares, if Neil resigns from his position as a non-executive

director of SeaLink (other than retirement as required under SeaLink's constitution), the Board will consult with him to agree another nominee of Neil to be appointed to the Board. Any such nominee would be subject to re-election at the subsequent annual general meeting.

Neil holds a Bachelor of Arts Degree and a Masters of Transport Management from the University of Sydney and is a Fellow of the Chartered Institute of Transport and Logistics.

The Board considers that Mr Smith's skills and experience are important given the Company's public transport and international operations. Mr Smith is considered by the Board to be a non-independent director.

Directors' Recommendation

The Directors (other than Mr Smith who makes no recommendation) unanimously recommend that shareholders approve Resolution 3 for the election of Mr Neil Smith as a Director of the Company. The Chair of the Meeting intends to cast undirected proxies in favour of this Resolution.

AGENDA ITEM 4 - ELECTION OF LANCE HOCKRIDGE

In accordance with clause 58.2 of the Company's Constitution, Mr Lance Hockridge who, having been appointed to fill a casual vacancy in the Board since the last Annual General Meeting of the Company, resigns and being eligible, offers himself for election.

Mr Hockridge has extensive international experience in the transportation, manufacturing and logistics sectors with a focus on safety, operational and financial transformation of businesses. Mr Hockridge was previously the Managing Director and CEO of Aurizon Holdings Limited (2010 to 2016) following the demerger of Queensland Rail and QR National from a government owned railway into an ASX50 company. Other notable accomplishments as an executive include the oversight of BHP's global transport business, together with key roles in financial and operational reform in the heavy industrial sector and leading a major turnaround for BlueScope Steel's North American operations.

Mr Hockridge is also currently Chair of the Salvation Army Queensland Advisory Council, and an active advocate for diversity in the workforce.

The Board considers that Mr Hockridge's extensive international and organisational leadership experience in the transportation manufacturing and logistics sectors with a focus on safety, operational and financial transformation of businesses are a valuable addition to the composition of the Board.

Mr Hockridge is considered by the Board to be an independent director.

Directors' Recommendation

The Directors (other than Mr Hockridge who makes no recommendation) unanimously recommend that shareholders approve Resolution 4 for the election of Mr Lance Hockridge as a Director of the Company. The Chair of the Meeting intends to cast undirected proxies in favour of this Resolution.

AGENDA ITEM 5 - RE-ELECTION OF JEFFREY ELLISON

In accordance with clauses 59.1 and 59.4 of the Company's Constitution, Mr Jeffrey Ellison will retire at the Annual General Meeting and, being eligible, offers himself for re-election.

Mr Ellison holds a Bachelor of Arts Degree in Accounting from the University of South Australia, is a Fellow of the Chartered Accountants Australia and New Zealand and the Institute of Company Directors. He has held the position of Chief Executive Officer of the Company since 1997 and was appointed Managing Director in 2008.

Mr Ellison retired as Managing Director and CEO on 16 January 2020 and, following a month of transition as an Executive Director, became a non-executive director from 17 February 2020. He was subsequently appointed Deputy Chair with effect from 26 February 2020 and Acting Chair on 1 July 2020.

Mr Ellison is a member on Tourism Australia Board (Deputy Chair). Mr Ellison is a former Board member of the South Australian Tourism Commission, Tourism and Transport Forum Australia, the Adelaide Convention Centre and the South Australian Botanic Gardens and State Herbarium Board.

The Board considers that Mr Ellison's skills and experience of the tourism and marine industries as well as mergers and acquisition/growth are an important part of the overall board skills composition mix. Mr Ellison is considered by the Board to be a non-independent director.

Directors' Recommendation

The Directors (other than Mr Ellison who makes no recommendation) unanimously recommend that shareholders approve Resolution 5 for the re-election of Mr Jeffrey Ellison as a Director of the Company. The Chair of the Meeting intends to cast undirected proxies in favour of this Resolution.

Proxies and Voting

Determination of Shareholders' Right to Vote

For the purposes of this Meeting, shares will be taken to be held by persons who are registered as Members as at 6:30 p.m. Adelaide time (ACDT) on Sunday 25th October 2020. Accordingly, transactions registered after that time will be disregarded in determining shareholders entitled to attend and vote at the Meeting.

Voting by poll

All resolutions at the Meeting will be voted on by poll.

Virtual Meeting

After considering the interests of the health and safety of shareholders, staff and other stakeholders the Board has decided to hold this year's meeting virtually. Unfortunately, shareholders will not be able to physically attend the meeting.

We are providing shareholders and proxyholders with the opportunity to participate in the AGM online. Shareholders and proxyholders may participate in the Meeting via the Lumi platform (if using a computer to participate), or via the Lumi AGM app (if using a mobile phone or device to participate).

Voting by Corporate Representative

Body corporate Members may attend and vote during the meeting via corporate representative by using the Lumi website or theLumi app using the Voting Access Code found on the Proxy Form. Only one login per body corporate with voting rights will be permitted and any other people from the body corporate wishing to attend should register as guests to attend the meeting. By entering the body corporate's Voting Access Code you will be taken to have certified to SeaLink pursuant to section 250D of the Corporations Act that you have been validly appointed as the body corporate's representative to exercise all or any of the powers the body corporate may exercise at the AGM.

Appointment of a proxy

Even though the Meeting is being held entirely virtually, you may still participate by appointing a proxy prior to the Meeting. Due to COVID-19, we strongly recommend you appoint the Chair of the Meeting as your proxy and that you actively direct your proxy how to vote on each item of business by marking the appropriate boxes on the Proxy Form.

A Member entitled to vote at the AGM may appoint not more than two proxies to attend (virtually) and vote at the AGM on that Member's behalf. A proxy need not be a Member of the Company.

A Member who is entitled to cast two or more votes may appoint not more than two proxies to attend (virtually) and vote at the AGM. If you appoint two proxies, you may specify the proportion or number of votes each proxy is appointed to exercise. If no such proportion is specified, each proxy can exercise half of the shareholder's voting rights.

If the appointment of a proxy directs the proxy to vote on an item of business in a particular way, the proxy may only vote on that item as directed. However, unless the proxy is required by law to vote, the proxy may decide not to vote on that item. All directed proxies that are not voted on a poll at the AGM will automatically default to the Chair, who is required to vote the proxies as directed. Any undirected proxies on a given resolution may be voted on by the appointed proxy as they choose, subject to voting exclusions as described previously.

In the case of shares jointly held by two or more persons, any joint holder may appoint a proxy but if more than one is present at the Meeting (either in person or by proxy or attorney or representative) the joint holder whose name appears first in the Company's share register shall alone be entitled to vote in respect of those shares.

Members who wish to appoint a proxy may do so by returning a completed Proxy Form in addition to the power of attorney or other authority (if any) under which it is signed (or a certified copy) to the Company through its share registry.

Lodging a Proxy Form

To be effective, the completed Proxy Form, together with any relevant power of attorney, must be received at the Company's share registry - Boardroom Pty Limited not less than 48 hours before the time for holding the Meeting, which is 4:00 p.m. Adelaide time (ACDT) on Sunday 25th October 2020. 




