Spark New Zealand Employee Share Purchase Scheme

Summary of Material Terms

General

In 2015, Spark established an IRD approved employee share purchase scheme – known as Spark Share. The essential features of Spark Share are:

- the issue of ordinary shares in Spark New Zealand Limited ("**Spark**") to participating employees at market price, less a discount;
- the shares are held on behalf of the participating employees by a trustee, Spark Trustee Limited ("**Trustee**"), for a restrictive period (usually three years); and
- the provision of an interest free loan for the amount of the shares, which must be repaid within three years ("**Loan**").

Any dividends paid on the shares is paid directly to the participating employees, however, participating employees may not vote shares held by the Trustee. There are no other hurdles that Spark or the participating employee must satisfy for the shares to vest after the restrictive period and payment of the Loan.

Leavers

When leaving Spark, the treatment of participating employees regarding their shares depends on why they are leaving:

- special leavers (redundancy, retirement, death or accident) may receive either their shares after paying off any Loan balance or (except in case of death) request the Trustee purchase their shares for the lower of the current market value or the original Loan amount; and
- other leavers must sell their shares to the Trustee for the lower of the current market value or the original Loan amount.

Capital changes

A capital change in Spark has the following impacts on Spark Share:



September 2020

- Rights issue: Spark may either offer the rights directly to the participating employee or to the Trustee, with participating employees required to direct the Trustee to exercise or sell the rights, if possible. The participating employee must pay the Trustee any sum necessary to exercise the rights.
- Takeovers or capital reorganisation: If permitted by the relevant Income Tax Act 2007 provisions, the Trustee has discretion which includes to:
 - hold any shares resulting from a reorganisation for the participating employees;
or
 - use cash acquired to pay participating employees (after repayment of the Loans); or
 - acquire shares in another company.
- The Trustee has discretion to accept or reject any takeover or capital reorganisation.

There are special rules that apply in cases of serious hardship or default.
