The following terms and conditions apply to the Options:

(a) Entitlement

Each Option entitles the holder to subscribe for one fully paid ordinary share in the capital of the Company (Share) upon exercise of the Option.

(b) Exercise Price and Expiry Date

The Options have an Exercise Price of \$3.95 per Option and will expire at 5:00pm AEST on or before 29 September 2023.

If the Options are not exercised before the Expiry Date will automatically lapse on the Expiry Date.

(c) Vesting Terms

50% of the Options will vest on 29 September 2021 and 50% of the Options will vest on 29 September 2022 (Vesting Dates) subject to the holder continuing to be employed by the Company up to the relevant Vesting Date.

(d) Exercise Period

The Options are exercisable at any time and from time to time from the Vesting Date to on or prior to the Expiry Date.
