## Issue of Shares

Sydney, Australia, 9 October 2020 – Splitit Payments Ltd. (ASX:SPT “**Splitit**” or the “**Company**”), a global payment solutions provider, advises that it has issued 42,727 fully paid ordinary shares (**Shares**) upon the exercise of 50,000 unlisted options (**Options**), pursuant to the cashless exercise facility under the Company’s Share Incentive Plan (**SIP**), after the satisfaction of the relevant vesting conditions applicable to the Options. The Options were issued under the SIP

A cleansing statement in respect of the Shares is set out below and an Appendix 2A is enclosed.

### Cleansing Statement

The Company hereby notifies ASX under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Act**) that:

- a) today, 9 October 2020, the Company completed the issue and allotment of 42,727 fully paid ordinary shares;
- b) the Company issued the shares without disclosure under Part 6D.2 of the Act;
- c) the Company provides this notice under section 708A(5)(e) of the Act;
- d) as a disclosing entity, the Company is subject to regular reporting and disclosure obligations;
- e) as at the date of this notice, the Company has complied with the provisions of Chapter 2M and section 674 of the Act as they apply to the Company;
- f) for the purposes of section 708A(7) and (8) of the Act, the Company wishes to disclose that the Company is currently engaged in negotiations with several prospective third party financiers in respect of additional merchant funding facilities. If agreed, such facilities may be material for Splitit to the extent that they enable Splitit to progress into new markets or achieve significantly greater scale. While Splitit is hopeful that a facility agreement will be agreed on terms acceptable to Splitit in the coming weeks, there is no guarantee that any facility will be agreed in the near or long term. A detailed announcement will be made if and when such negotiations become binding or complete in accordance with the Company’s continuous disclosure obligations; and
- g) other than as set out in this announcement, there is no information that has been excluded from a continuous disclosure notice in accordance with the ASX Listing Rules and that



investors and their professional advisors would reasonably require for the purpose of making an informed assessment of:

- (i) the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
- (ii) the rights and liabilities attaching to the Shares.
