**5G NETWORKS LIMITED (ASX: 5GN) ANNOUNCES EXTENSION OF THE OFFER PERIOD UNDER ITS TAKEOVER BID FOR WEBCENTRAL GROUP LIMITED (ASX:WCG)**

5GN lodged its bidder's statement on 18 September 2020 in relation to its takeover bid for all of the fully paid ordinary shares in Webcentral Group Limited (**WCG**) (**Offer**). The Offer was due to close on Tuesday, 20 October 2020.

5GN has become aware that as a result of COVID-19, some WCG shareholders may have experienced postage delays in receiving 5GN's Bidder's Statement as well as WCG's Target's Statement. In light of this 5GN has resolved to extend the closing date of the Offer by 7 days to allow WCG shareholders additional time to consider the Offer and provide acceptances.

5GN's Offer is now scheduled to close at **7.00pm (Sydney time) on Tuesday, 27 October 2020** (unless extended). The new date for 5GN giving the notice of the status of defeating conditions is **Friday, 16 October 2020**.

A copy of the extension notice, as lodged with ASIC today, is attached to this announcement (**Extension Notice**). The Extension Notice has also been served on WCG and despatched by post to all WCG shareholders' today.

This notice (**Notice**) is given under section 650D(1) of the Corporations Act 2001 (Cth) (**Corporations Act**) by 5G Networks Limited ACN 163 312 025 (ASX: 5GN) (**5GN**) in relation to its offers dated 18 September 2020 (each an **Offer**) under its off-market takeover bid to acquire all of the fully paid ordinary shares on issue in WCG. The Offer is contained in 5GN's bidder's statement dated 18 September 2020 (**Bidder's Statement**). Unless otherwise defined in this Notice, words defined in the Bidder's Statement have the same meaning in this Notice.

### Extension of Offer Period

5GN gives notice under section 650D(1) of the Corporations Act that pursuant to section 650C(1) of the Corporations Act it varies the Offer by extending the Offer Period such that the Offer will remain open for acceptance from the date of the Offer until 7:00 pm (Sydney time) on 27 October 2020, unless further extended.

### Notice for status of defeating conditions

In addition, for the purposes of section 630(2)(b) of the Corporations Act, 5GN gives notice that its Offers contained in the Bidder's Statement are varied such that the new date for the purposes of giving notice of the status of defeating conditions will be 16 October 2020.

As at the date of this Notice, none of the defeating conditions to the Offer in section 15.8 of the Bidder's Statement has been freed or, so far as 5GN knows, fulfilled and, accordingly, the Offer remains subject to those defeating conditions.

### Amendments

The Bidder's Statement is amended by substituting the date "20 October 2020" for the date "27 October 2020" in all places in the Bidder's Statement where the date "20 October 2020" appears as the closing date of the Offer.

The Bidder's Statement is amended by substituting the date "9 October 2020" for the date "16 October 2020" in section 14.2 of the Bidder's Statement where the date "9 October 2020" appears as the date for giving notice of status of the defeating conditions.

This Notice is dated 9 October 2020. A copy of this Notice was lodged with ASIC on 9 October 2020. ASIC takes no responsibility for the contents of this Notice.
