

# Adore Beauty Group Limited (ACN 636 138 988) ("Company")

## **Corporate Governance Statement**

Clauses 3 and 9 of the Board Charter set out the responsibilities delegated to the CEO, management and the company secretary.

The Company has adopted a People and Remuneration Committee (PRC) Charter. The Company complies with this recommendation. At the time of listing, the ARMC will be comprised of two independent non-executive directors (one of whom will serve as chair of the ARMC, being Sandra Birkensleigh) and one non-independent non-executive director.

The Company has established an ARMC which is governed by the ARMC Charter which sets out its roles and responsibilities.

Clause 2(a) of the ARMC Charter provides that the Committee should to the extent practicable, given the size and composition of the Board from time to time, comprise of:

- at least three members:

Clause 2(c) of the Charter provides that the chair of the Committee should be an independent non-executive director who does not chair the Board.

The ARMC Charter will be disclosed on the Company's website.
