Shareholders will be able to participate at the AGM by using their personalised log-in on the Proxy Form. The AGM portal will be open to ask questions prior to the meeting from Monday, 23 November 2020. Shareholders can also submit questions in advance of the AGM by emailing questions to Mr Malcolm Cowell, Company Secretary at malcolm.cowell@bnk.com.au by no later than 5pm (AEDT) on Thursday, 19 November 2020. You may also submit your questions and comments online during the AGM via the Meeting Platform.

To vote at the AGM, you are encouraged to appoint a proxy, preferably the Chair of the AGM, to vote on your behalf at the AGM as this will simplify the voting procedures for the AGM. Alternatively, you will be able to record your vote during the AGM through an online poll, subject to any conditions contained in the Notice.

Completed proxy forms should be returned to the address set out below as soon as possible, and in any event, must be received by no later than 2.00pm (AEDT) on Tuesday, 24 November 2020, being not less than 48 hours before the commencement of the AGM. Any proxy voting instructions received after that time will not be valid for the AGM.
