Issue of Employee Share Rights by Employee Share Trust

Ecofibre Limited (Ecofibre, Company) (ASX:EOF, OTC - Nasdaq Intl Designation: EOFBF)

Pursuant to Listing Rule 3.10.3A, Ecofibre advises that 359,000 employee share rights have been issued to staff in relation to existing shares held by the Company's Employee Share Trust (EST). None of these staff are Key Management Personnel (KMP).

Appendix 3G Notification of Issue, Conversion or Payment Up of Equity Securities is attached.

The issue of employee share rights does not change the total number of shares on issue. All shares held by the EST were approved by shareholders in 2016, and issued prior to Ecofibre's listing in March 2019.

Employee share rights are typically issued to new staff at the commencement of their employment, or after completion of a qualifying period. Shares then vest and are issued to staff if relevant time-based or performance-based hurdles are met.

Ecofibre's share scheme is part of its standard remuneration practice. The Board believes that all employees should be given the opportunity to become shareholders in our business, and that the share scheme helps engage, retain and motivate employees over the long term.
