2020 Annual General Meeting (AGM) Chairman's Address on 5th November 2020

Dear fellow shareholders, I'm pleased to welcome you to the fifth AGM of Monash Absolute Investment Company Limited (ASX: MA1).

This year's AGM will be held online via the Lumi App or on https://web.lumiagm.com/338806048 on 5th November 2020 at 11am (AEDT.

Financial Result and Performance Update

The Company's pre-tax Net Tangible Assets (NTA) grew by 6.12% for the 2019-20 financial year based on the opening and closing pre-tax NTA, after fees and expenses. This was a very good result as the ASX200 was -7.68%. The Company's share price at 30 June 2020 was \$0.9850. As at the 30 June 2020, the pre-tax net tangible asset backing (NTA) of the Company was \$1.1043 per share. The post- tax NTA at the 30 June 2020 was \$1.0820 per share.

The Company has also had a positive start to the 2020/21 financial year with a positive return of +11.91% for the financial year to 31 October 2020 (after fees and expenses) and a NTA pretax of \$1.2258 per share.

Simon Shields will be presenting a CIO update today and provide more information on the latest performance results for the Company.

Options

A total of 538,369 bonus options were exercised during the financial year. Upon the exercise of the bonus options, the Company issued an equal number of loyalty options at an exercise price of \$1.15 per share with an expiry date of 15 November 2021. No loyalty options have been exercised during the financial year.

Fully Franked Dividend

The Board declared a fully franked dividend of 1 cent per share for the Financial Year ended 30 June 2020. This was paid on 30 October 2020.

Update on the proposed restructure of the Company into an ETMF

The Company announced on 5 May 2020 that it had executed an implementation agreement with The Trust Company (RE Services) Limited to implement the restructure. Further on 3 September 2020, we provided an update on the milestones achieved to date including the establishment of the new fund, called the Monash Absolute Active Trust, negotiation of key service provider agreements with an internal market maker, administrator and prime broker and making an application to the ASX to have the fund admitted as an ETMF.

As previously announced the proposal will require shareholder approval. A notice of meeting and explanatory information will be sent to shareholders with the aim to completing the





restructure in early 2021. We will provide an updated on the timetable when the notice of meeting is dispatched to shareholders.

Corporate Governance Matters

During the year the non-executive directors are pleased to report they have continued to monitor the performance of the Investment Manager, Monash Investors Pty Ltd, and its adherence to the Investment Management Agreement. We are confident in the integrity and reporting of the Company's financial results to shareholders.

We welcomed Paul Jensen who was appointed as an additional Independent non-executive Director on 29 October 2020. Paul is a highly qualified and experienced company director, with specific experience in LIC's at WAM Capital, Future Generation Limited and Hunter Hall Global Value Fund. With the proposed restructure into an ETMF well underway, the Board believes that an additional resource with Paul's expertise would be valuable.

In closing, I would like to thank my fellow Board members for their valuable contributions to the Company and the Investment Manager's team for their solid and productive effort in managing the Company's portfolio.



- 4. You will receive confirmation that your question has been received.


The Chair will give all Shareholders a reasonable opportunity to ask questions and will endeavor to answer all questions at the Meeting.
