The following information is provided to ASX Limited ("**ASX**") for release to the market in connection with the official quotation of 120,372,409 fully paid ordinary shares in Hexima Limited ACN 079 319 314 (ASX:HXL) ("**Hexima**").

Unless otherwise defined, capitalised terms used in this notice have the meaning given to them in Hexima's prospectus dated 15 October 2020 ("**Prospectus**").

1 Completion of Offer

Hexima confirms that the Offer closed on 13 November 2020 and has issued 15,000,000 New Shares at an issue price of \$0.20 per Share and 1,403,854 Sale Shares at a sale price of \$0.20 per Share.

Hexima has received a total of \$3,280,770.80 from successful Applicants under the Offer.
