CHANGES TO MRG BOARD: NEW DIRECTOR APPOINTED

John has a proven track record of over 25 years of high-performance executive leadership and directorship experience across several publicly listed and private companies. He has delivered strong outcomes based on creating value and growth through financial discipline, capital allocation, strategy development and execution.

Most recently John was Group CEO of the Indigenous Land and Sea Corporation (ILSC), one of the country's largest agribusiness and tourism enterprises. Prior to heading up the ILSC Group, John was the long-term Managing Director and CEO of the ASX listed rural services company, Ruralco Holdings Ltd, for nine years. During his tenure, Ruralco was one of Australia's fastest growing and highest returning agribusinesses consistently generating substantial and sustained increases in revenue, profit and market capitalisation. Prior to Ruralco, John was a senior executive at Wesfarmers Ltd for 10 years and AWB Ltd for two years where he led the Landmark (now Nutrien) rural services business to then record profit and return on capital levels.

John has an honours degree in Agricultural Science from Sydney University, an MBA from AGSM (University of NSW), studied global agribusiness at Harvard University and has completed the Advanced Management Program at INSEAD Business School. He is a graduate of the AICD and is a recipient of Sydney University's Alumni Outstanding Achievement Award.
