#### Amended Appendix 3X - Initial Director's Interest Notices

Cashrewards Limited (ASX:CRW) (the **Company**) advises there was a minor error in the Appendix 3X – Initial Director's Interest Notices filed on behalf of Rajeev Gupta and Andrew Clarke on 2 December 2020.

The Notices mistakenly said that a portion of Mr Clarke and Mr Gupta's shares would be subject to voluntary escrow arrangements until 1HY21. However, those shares are instead subject to voluntary escrow arrangements until 1HFY22.

In addition, the Appendix 3X – Initial Director's Interest Notice filed on behalf of Brett Johnson mistakenly indicated his shareholding in the Company as nil. However, Mr Johnson was in fact allotted 28,902 shares under the Company's IPO.
