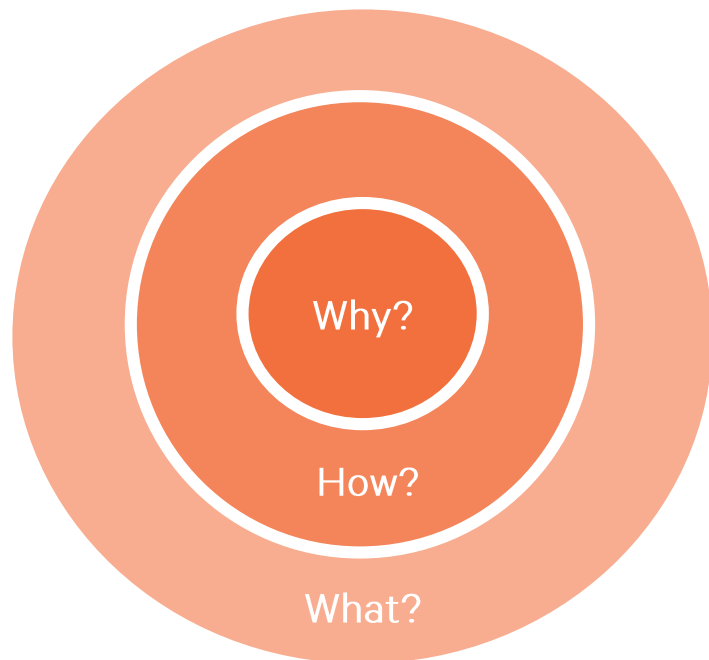

Selecting and partnering with the best in class alternative fund managers through robust investment and operational due diligence leveraging the experience, skills and network of the investment team and the investment committee.

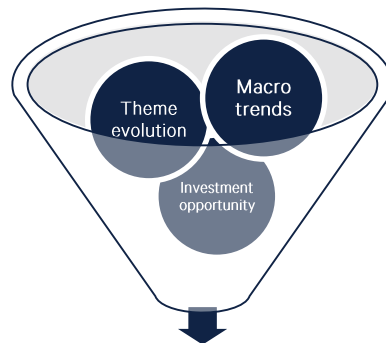
## **What – the result**

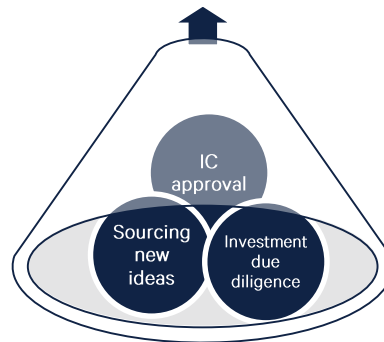
