Issue of cleansing notice under section 708A of the Corporations Act 2001 (Cth)

Megaport Limited ACN 607 301 959 (ASX: MP1) (**Megaport**) advises that it issued 100,000 fully paid ordinary shares on 23 December 2020 (**Shares**), following the exercise of an equivalent number of options in Megaport issued under its employee share option plan. An Appendix 2A in relation to the issue is attached.

Megaport issued the Shares without disclosure to investors under section 708A(5) of the *Corporations Act 2001* (Cth) (**Corporations Act**).

As required by section 708A(6) of the Corporations Act, Megaport advises that:

- (a) the Shares were issued without disclosure to investors under part 6D.2 of the Corporations Act;
