### Preliminary Estimate Pre-Tax NTA \$1.4712

### Change in Portfolio Value +34.31% FYTD

This compares to the S&P/ASX200 +15.41% and the S&P/ASX Small Ordinaries +20.23%

This should be seen as a guide of underlying Company performance for the month to date. A number of final adjustments may need to be made in calculating the NTA, which will be released as usual on a monthly basis.
