### Acquisition of 9.18% interest in Irongate Group (ASX:IAP)

In line with 360 Capital REIT's (ASX:TOT) refined strategy of real estate equity investing, TOT has acquired a 9.18% strategic investment in Irongate Group (ASX:IAP) for approximately \$78.6 million. IAP is an ASX listed diversified REIT with approximately \$1.1 billion of assets on balance sheet and a third-party funds management platform.

Separately, TOT has agreed terms to become a major equity partner in an unlisted real estate funds management platform (subject to completion of due diligence) with settlement expected prior to HY21 results on 26 February 2021.

Head of Real Estate, James Storey said, "Following these investments TOT will have deployed approximately \$135 million, being the majority of TOT's available capital into strategic equity holdings in real estate funds management platforms with gross assets of approximately \$4.0 billion".

Based on the recurring nature of the income from these investments, TOT provides distribution guidance of 6.0cps for FY21.
