**Completion of Transactions**

The Directors of Easton Investments Limited (**Easton** or **the Company**) advise that with effect from today's date:

- The acquisition of Paragem Pty Limited by Easton from HUB24 Limited (**HUB24**) has been completed and the holding lock on the 3,333,333 million Easton shares issued to HUB24 as consideration has been removed;
- The Technology Partnership & Distribution Agreement between Easton and HUB24 is now in place as a framework to explore software development projects and 1,700,000 Easton options have been issued to HUB24 as consideration – an Appendix 3G Notice of Issue of Equity Securities is appended hereto; and
- The divestment of Panthercorp CST Pty Limited by Easton to Sequoia Financial Group Limited has been completed.

In addition, the relatively small acquisition of the outstanding interest in Taxbytes Pty Limited (**Taxbytes**) is expected to be completed in coming days, involving a cash payment by Easton of approximately \$250,000 and taking Easton's interest in Taxbytes from 65% to 100%. TaxBytes is a provider of in-house training to the accounting profession.
