The change in voting power of Macquarie Agricultural Funds Management No.2 Pty Limited ("MAFM2") arises as a result of the divestment of Vitalharvest Freehold Trust securities by Macquarie Investment Management Limited ("MIML") which manages investments of clients of Macquarie Group. MAFM2's relevant interest in 30,000,000 securities through the entry into a Call Option Deed with Primewest Management Ltd on 17 November 2020 remains unchanged.

As noted in MAFM2's initial substantial holder notice, MAFM2's relevant interest and voting power increased to 18.55% at the time of entry into the Call Option Deed, when combined with other relevant interests held by Macquarie Group entities. Following the divestment by MIML referred to above, MAFM2's relevant interest has decreased to 16.40% as at 1 February 2021. The total voting power above arises as a result of the aggregation of MAFM2's relevant interest with that of Primewest Agrichain Management Pty Ltd who became an associate of MAFM2 as a result of entering into a Facilitation Deed on 17 November 2020 with respect to the management of Vitalharvest Freehold Trust. Primewest Agrichain Management Pty Ltd's relevant interest of 19.87% includes the relevant interest in the securities the subject of the Call Option Deed which are therefore not double counted.

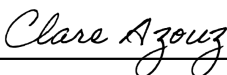
